



For the knowing by all Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire existing as a Constitutional Monarch, that this Constitution is the Imperial Constitution of the Continental Mu'urish Yamaxi Empire-CMYE, and was prepared for the Indigenous Peoples of the Continental Mu'urish Yamaxi Empire-Mu'urish Yamaxi American Natives- Olmec Civilization, Guided by the Emperor-Monarch-INRI :Khufu-Ranub-Zodoq :Sampson-El':Red-Eagle:Thunder-Fire', :Sambhu-Re , Droit!

This is the general law definition of the Word Constitution. In American Law, it is defined as:

"The written instrument agreed upon by the people of the Union or of a particular state, as the absolute rule of action and decision for all departments and officers of the government in respect to all the points covered by it, which must control until it shall be changed by the authority which established it. And in opposition to which any act or ordinance of any such department or officer is null and void."

So in American Law, the Constitution was agreed upon by the People of the Union or of a Particular State as the <u>absolute power</u>, which can only be changed by the authority which established it. We as Muurs-Moors <u>did</u> contribute to the making of the Constitution of the Union of the united States of America, thus as mentioned in the definition above, we as Muurs-Moors have the Authority and Power to Change and abolish this Constitution. This fact can be observed by Abraham Lincoln's own words when he challenged the American Jurist and the 5th Chief Justice Roger Brooke Taney's (1777-1864 A.D.) Decision in the Dred Scott Case, Stating:

"Justice Taney, in delivering the majority opinion of the court, insists at great length that Moors were no part of the people who made, and for whom was made, the Declaration of Independence, or the Constitution of the United States. "On the contrary, Judge Charles Curtis (1860-1936 A.D.), in his dissenting opinion, shows that in five of the thirteen states, to wit, New Hampshire, Massachusetts, New York, New Jersey and North Carolina, Free Moors were voters, and the proportion to their numbers, had the Same part in making the Constitution that the white people had. He shows this with so much particularity as to leave no doubt of its truth; and as a sort of conclusion on that point holds the following language."

"The Constitution was ordained and established by the people of the United States, through the action, in each state, of those persons who were qualified by its laws to act thereon in behalf of themselves and all other citizens of the State. In some of the States, we have seen, Moorish persons were among those qualified by law to act on the subject. These Moorish persons were not only included in the body of the 'The People of the United States', by whom the Constitution was ordained and established; but in at least five of the States they had the power to act, and doubtless, did act, by their suffrages, upon the question of its adoption."

(Justice Curtis 1857 Dissenting Opinion, Dred Scott Case, also Lincoln-Douglas Debates)
