Be it enacted by Emperor-Monarch-[NR]: Sambhu Re 👑:

We the Indigenous Natives/People of the Continental Mu'urish Yamaxi Empire/Mu'urish Yamaxi American Natives-Olmec Civilization must learn to pass judgment justly and without prejudice!

We the Indigenous Natives/People of the Continental Mu'urish Yamaxi Empire/Mu'urish Yamaxi American Natives-Olmec Civilization Hereby Declare our Right to: Self-Determination and the Right to Self-Government In Matters Relating to Our Internal and Local Affairs including Culture, Religion, Information, Education, Media, Health, Housing, Employment, Social Welfare, Economic Activity, Land and Resources, Management, Environment, Financial Security, and Welfare.

We have to teach our Children to deal justly in all Acts of their Lives, when dealing with those of our Empire-Kingdom, and Family at Home and Abroad.

Imperial Law 4: Peace

Be it enacted by Emperor-Monarch-[NR]: Sambhu Re 👑:

We the Indigenous Natives/People of the Continental Mu'urish Yamaxi Empire/Mu'urish Yamaxi American Natives-Olmec Civilization must Change the Condition of the State of Mind that we are in, in Order to live in a Harmonious, Well-Balanced, Stable, Peaceful Environment. We have to Change the Course of our Lives for the Better, which will Change the way our Children were and are being programmed. We must Create Environments Suitable and Protective.

Imperial Law 5: Freedom

Be it enacted by Emperor-Monarch-[NR]: Sambhu Re 👑:

We the Indigenous Natives/People of the Continental Mu'urish Yamaxi Empire/Mu'urish Yamaxi American Natives-Olmec Civilization must know that by Nature we are a Free People and are neither Slaves, nor Unintentional Servants to any, Save Ourselves and only on the case of a Punishment of a Crime whereof the Party shall have been Duly Convicted by a Court and a Jury of his or her Peers, that is, a National of the Continental Mu'urish Yamaxi Empire/Mu'urish Yamaxi American Natives-Olmec Civilization all of which we are, their only peers being of the same Genetic Historical and Indigenous Origin. Remember, no matter what time of day we are within, we always have an opportunity to renew our own vitality through recognizing self-importance and recognizing the importance of our own life; like the Elevation of the Divine from Beast to Man to Human to Human Being to Supreme Being to Being!

Imperial Law 6: Love

Be it enacted by Emperor-Monarch-[NR]: Sambhu Re 👑:

We the Indigenous Natives/People of the Continental Mu'urish Yamaxi Empire/Mu'urish Yamaxi American Natives-Olmec Civilization must Re-learn to Love ourselves. We must care. We must Love our Images, our Cultures, our Past Contributions to World Improvement and Accomplishments. This will breed the Love of others as we learn to Love our Indigenous Mu'urish Yamaxi Selves. That is both our appearance, as well as our intelligence. We must Re-learn to accept all Indigenous Mu'urish Yamaxi American Natives-Olmec Civilization as family. We are one

community or people with the same origin. We must reject all foreign given titles that we do not choose to be called or identified by. We must reject all Religions and Cultures that do not highlight our Presence and Cultures. We must respect each and every foreign Religion, Culture, People and their Customs in the States or Countries in which they live. The freedoms of choice and self-determination in the environments in which they belong; we must become more concerned with the health, welfare, environment, and economic, mental, and physical stability of ourselves and each other.

We must do all in our Power to prevent our people from mental depression and physical degradation and self-destruction by the use of any and all substances of abuse. For we practiced by Nature, healthy living before we came in contact with those who wished us Physical and Mental harm.

Imperial Law 7: Joy

Be it enacted by Emperor-Monarch-INRI: Sambhu Re :

We the Indigenous Natives/People of the Continental Mu'urish Yamaxi Empire/Mu'urish Yamaxi American Natives-Olmec Civilization must create our own Happiness, Activities, Entertainment, and Enjoyment by utilizing our cultural Backgrounds, Customs, Traditions, Dances, Ancient and Old Musical Instruments, etc... We must take the responsibility for our own happiness mentally, spiritually and physically for we are unlike those around us, and amongst whom we presently live. Remember, no matter what time of day we are within, we always have an opportunity to renew our own vitality through recognizing self-importance and recognizing the importance of our own life!

Imperial Law 8: Unity

Be it enacted by Emperor-Monarch-INRI: Sambhu Re :

We the Indigenous Natives/People of the Continental Mu'urish Yamaxi Empire/Mu'urish Yamaxi American Natives-Olmec Civilization must become one in: all areas of life, mind, matter, body, psychic, soul, physical, emotional, mental, spiritual, financial, social, wants, pursuits; and learn to live together as a family; meaning, we have to drop our ego's (worldly pursuits) and learn to live for, of, and by each other. For our future assurance, we must work together, cooperate and facilitate the qualifications, skills and artistic abilities of those in our own Empire-Kingdom, to create stable, sound, productive, and progressive communities of Unity.

Imperial Law 9: Success

Be it enacted by Emperor-Monarch-INRI: Sambhu Re :

We the Indigenous Natives/People of the Continental Mu'urish Yamaxi Empire/Mu'urish Yamaxi American Natives-Olmec Civilization must Re-instill in our people the realities that Success and Succession comes from cooperation and participation. We must work together to accomplish Goals that would result in our Success as a People. We must Support each other in all matters of life. We must learn to depend on trust, respect and help one another, in order to succeed in any and all of our undertakings. We must utilize our highest Potential. We must learn to proceed through blocks, over hurdles, and through pit-falls that are set up to hold back our progress, growth, and success by those who fear our ability of self-rule, government, determination, and progress as a people. The disagreeable beings, be they force or human, spends much time trying to deceive us into being none but ourselves and our kind. We must set Vivid, not Unclear Goals for ourselves as Autonomous Autochthon people and put full force in making the best of our time, resources, sources, skills, talents and education in order to be a successful Empire-Kingdom.

Imperial Law 10: Law

Be it enacted by Emperor-Monarch-[NR]: Sambhu Re 🙏:

Section 1:

We the Indigenous Natives/People of the Continental Mu'urish Yamaxi Empire/Mu'urish Yamaxi American Natives-Olmec Civilization must not make nor accept any law that does not relate to us as a people by Nature. We are not to respect laws made, forced or enforced upon us by those who do not have our best interest, health, welfare, or wealth in mind. We are not to make religious restrictions and laws that have been inscribed by any or some supernatural being for us, to help us. We are not to create laws for others that do not apply to their nature or safety and well being. We are to respect the laws of others that pertain to them, not to the point of abiding by them; but simply out of due respect and the principle of Law and Enforcement. We are to enforce our Imperial laws amongst our Autonomous Autochthon Empire-Kingdom. We are to make Imperial laws that are Acceptable, Agreeable, and Comprisable to all the Indigenous People of our Empire-Kingdom. We are not to put restrictions on individuals from self-determination and pursuits. Those are in violation of others privacy or safety. We are to live by the Imperial laws in our Imperial Constitution.

For the knowing by all the Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire existing as a Constitutional Monarch: that the Forty Two laws or precepts of Maat are part of the Imperial laws or precepts that all Mu'urish Yamaxi American Natives-Olmec Civilization Govern themselves by "The injunctions of Maat where statements composed by the Sages of Ancient Egypt and recorded in temple walls and papyrus scrolls, which have survived to this day. They were to be used by spiritual initiates for the purpose of cleansing their personalities and making themselves pure vessels in order to promote spiritual self-discovery. These teachings came to be known as the Book of the Dead. The correct name is *Prt m Hru* or *Pert Em Heru* meaning 'Utterances for Coming into the Light of the Most High (Supreme Self-God) or the Wisdom and Practices which make one becoming spiritually enlightened."

Section 2:

True indigenous natives/nationals of the Continental Mu'urish Yamaxi Empire are recognized as having our own Imperial Royal Embassy, Imperial Indigenous Matriarchal Council, Imperial Indigenous Marshals, Imperial CMYE Government and Imperial Mu'urish Yamaxi Consulate to facilitate dealings with all Nationals Affairs. Continental Mu'urish Yamaxi Empire Nationals are the bearers of the Names, (Nin, Nanya, Nayya), for the beginning of our Name and (Ei, Dey, Bey, Ali and Re), at the end of our name if we choose; we are the true indigenous natives/people of the

Americas (Amexem), the land of Our forefathers and mothers of "Yamaxi, Olmec, Xi, Waxitaw, Mu'urish-Muur-Moor-Moorish/Moorish Americans-Al Moroccan, Original Xirokee, Inca, Choctaw, Occone, Yuchi, Osochi, Seminole, Creek, Garifuna, Xickasaw, Shushuni, Creek, Apalachee, Chatot, Apalachiola, Okmulgee, Lenápe, Sawoki, Shawnee, Tamathli, Yamacraw, including the Xicora, Mayan, Inca, Muskogeas, Blackfoot, Aztec, Anasazi, Shoctaws, Osages, Stono, Ottawa, Couxitta, and Etowa Descent". All Mu'urish Yamaxi American Natives-Olmec Civilization have a freehold inheritance to the land and retain all Inalienable Birth, Substantive and Inherent Rights, and though Constructive Agreements, Contracts, International Laws, Treaties and Immunities, enjoy and operate upon consummated, vested Constitutional Rights and Immunity(s) from Taxation, Criminal And Civil Jurisdiction by and of the Continental Congress of the union States Society of America - u.S. of A., united States America, United States of American, USA, INC; in harmony with but not limited to United States Supreme Court Acts of State to wit: "Every Sovereign State{people} is bound to respect the independence of every other Sovereign State (people) and the courts of one country (people) will not sit in judgment of the government of another, done within (the same or) its own territory"...

Under the "Imperial Constitution of the Continental Mu'urish Yamaxi Empire" in its entirety, including but not limited to the following of which the United States of America (federal government) is a signatory under affirmative obligations, both legal and moral, to provide effective judicial remedies for violations of Fundamental Rights and Human Rights, even when those violations were committed by persons acting in their official capacities, pursuant to but not limited to:

Be it enacted by Emperor-Monarch-INRI: Sambhu Re :

Section 1: Imperial Royal House of the Emperor-Monarch-INRI: Sambhu Re 


a. For the knowing by all Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire existing as a Constitutional Monarch: that the Imperial Royal House of the Emperor-Monarch-INRI: Sambhu Re  by an Emperor's Directive existed Wednesday, July 18, 2007 A.D., 'nunc pro tunc ~1513~Beginning for the Reigning Emperor-Monarch-INRI: Khufu-Ranub-Zodoq :Sampson-El 'Red-Eagle :Thunder-Fire' also Distinctive Appellations :Khufu-Sutukh :Ranub-El "Sambhu-Re", Droit!

Section 2:

a. For the knowing by all the Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire existing as a Constitutional Monarch: that the Continental Mu'urish Yamaxi Empire is Not a Communist, Order, nor a Church, Masjid, Synagogue or any other Religious Intuition, Club, Democracy, Organization, Republic, or Socialist, etc...

b. For the knowing by all the Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire existing as a Constitutional Monarch: that the Continental Mu'urish Yamaxi Empire is a free Independent Indigenous Sovereign Empire/Kingdom. Neither its Sovereignty nor any part of its Territories may be relinquished.


c. For the knowing by all the Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire existing as a Constitutional Monarch: that the Continental Mu'urish Yamaxi Empire is a non religious Government for all Mu'urish Yamaxi American Natives- Olmec Civilization! The Continental Mu'urish Yamaxi Empire is a *de jure* Imperial Empire/Kingdom for all Mu'urish Yamaxi American Natives- Olmec Civilization; Religious, Political and Historical Studies will be displayed at the Imperial I-Em-Hutip University.

d. For the knowing by all the Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire that the Imperial Executive Houses, Executive Houses, and Imperial CMYE Governmental Houses under the leading of the Continental Mu'urish Yamaxi Empire Constitutional Monarch: consists of one (1) Imperial Royal House of the Emperor-Monarch-INRI: Sambhu Re , eight (8) Imperial Executive Houses, seven (7) Executive Houses, and seven (7) Imperial CMYE Governmental Houses that service all aspects of Governance for the Continental Mu'urish Yamaxi Empire system of Government, Legislation, Representative and Structure.

e. For the knowing by all the Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire that the Continental Mu'urish Yamaxi Empire under the leading of the Continental Mu'urish Yamaxi Empire Constitutional Monarch: is for the maintaining and sustaining of the Continental Mu'urish Yamaxi Empire under the Directing of the Indigenous/Ancient Ones with the Authority for the Amending of the Imperial Constitution of the Continental Mu'urish Yamaxi Empire under the Authority of the Continental Mu'urish Yamaxi Empire Constitutional Monarch and/or with or without the Imperial Indigenous Matriarchal Council.

f. For the knowing by all the Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire that the Imperial Royal House of the Emperor-Monarch-INRI: Sambhu Re , Imperial Executive Houses, Executive Houses, and Imperial CMYE Governmental Houses under the leading of the Continental Mu'urish Yamaxi Empire Constitutional Monarch is the Imperial Central Governing Body of the Empire bearing of the Ultimate Overall Responsibility for the Overall Sanctity and Welfare of the Continental Mu'urish Yamaxi Empire.

g. For the knowing by all the Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire that the Imperial Royal House of the Emperor-Monarch-INRI: Sambhu Re, Imperial Executive Houses, Executive Houses, and Imperial CMYE Governmental Houses under the leading of the Continental Mu'urish Yamaxi Empire Constitutional Monarch: that the Security and Defense of the Empire/Kingdom is the Sole Responsibility of all Males obtaining the age of thirteen (13) to seventy-two (72);

- 1) The Men of the Imperial Royal House, all Imperial Governmental Houses and Indigenous Communities, Tribes and Clans within the Continental Mu'urish Yamaxi Empire will bear the titles 'Imperial Indigenous Marshals, Imperial Guardians, Imperial Community Marshals, Imperial Regional Marshals' and will serve as the Militia and Security for the Continental Mu'urish Yamaxi Empire, also;
- 2) Through General Law Enforcement and Military Training, all Men will have Total Training and Armament for Duty;
- 3) Imperial Law Regulates the Method and Time for preparing Military Cadres and for conducting General Military and Law Enforcement Training;
- 4) The Women of the Imperial Royal House, all Imperial Governmental Houses and Indigenous Communities, Tribes and Clans within the Continental Mu'urish Yamaxi Empire will also have a vital role in the security and well being of the CMYE.

Section 3:

For the knowing by all Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire existing as a Constitutional Monarch: that our Imperial Central Governing Body will consist of eight (8) Imperial Executive Houses, seven (7) Executive Houses, seven (7) Imperial CMYE Governmental Houses, with nineteen (19) Imperial Consuls, nineteen (19) Imperial Deputy Consuls, thirty one (31) Imperial Indigenous Matriarchal Council Members with One Imperial Secretary General, One Imperial Chief Deputy Secretary General and One Imperial Deputy Secretary General, One Imperial Continental Congress, One Imperial Ambassador and Imperial Chief Deputy Ambassador for each Imperial Royal Embassy, One Imperial Deputy Ambassador for each Consulate, one Empress and one Emperor.

Section 4:

General Description and functions of the Imperial Royal House of the Emperor-Monarch-INRI: Sambhu Re , Imperial Executive Houses, Executive Houses, and Imperial CMYE Government Houses:

a) Imperial Royal House of the Emperor-Monarch-INRI: Sambhu Re : For the knowing by all Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire that the Emperor-Monarch-INRI: Sambhu Re will appoint up to four (4), five (5) Star Generals for the Continental Mu'urish Yamaxi Empire who will assist the Emperor-Monarch with the teaching and bringing together of His Imperial Majesty Royal Post , the Imperial Indigenous Matriarchal Council, Imperial Law Counsels, Imperial Indigenous Marshals, etc., and ensure the training of all Imperial Officials, Ambassadors, Consuls, and Nationals involved in Imperial CMYE Governmental leadership.

b) For the knowing by all Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire that the Imperial Indigenous Marshals under the leading of the Continental Mu'urish Yamaxi Empire Constitutional Monarch: is the Militia Officials for the Continental Mu'urish Yamaxi Empire, who will also assist the National Security Forces for the Security of all the Imperial Guardians, Imperial Community Marshals and Imperial Regional Marshals within the CMYE. The actions of the personnel in this Division of the Imperial Central Government Structure are answerable to the Imperial Indigenous Matriarchal Council.

Imperial Indigenous Marshals training, and daily operation of the Imperial Law Enforcement Departments will be governed by the Imperial Laws of the Imperial Constitution of the Continental Mu'urish Yamaxi Empire and Protocols on the conduct of Imperial Law Enforcement Personnel in dealing with the general public:

Article 1: By an Emperor's Directive, be it enacted from the Imperial Royal House of the Emperor-Monarch-INR: Sambhu Re  for the Continental Mu'urish Yamaxi Empire, the Imperial Office of the Imperial Indigenous Marshals is Hereby with the Designation for the Protection of the Continental Mu'urish Yamaxi Empire, Indigenous Communities, Tribes and Clans across the CMYE part being of the Continent of Alkebu Lan (mis-named "North America," by the invading Europeans beginning in 1493 to the Present).

- (a) The Official Title of the Imperial Indigenous Marshal is for the Chief Imperial Law Enforcement Official of the Continental Mu'urish Yamaxi Empire and the qualification for this office is governed by the Committee for Imperial Law and Justice. The individual for this Office shall be selected by the Authority of the Continental Mu'urish Yamaxi Empire Constitutional Monarch and/or with or without the Imperial Indigenous Matriarchal Council.

Article 2: In each Indigenous Community within the Continental Mu'urish Yamaxi Empire, there shall be the office of Imperial Community Marshal, with the individual holding that Office will be selected by the Authority of the Continental Mu'urish Yamaxi Empire Constitutional Monarch and/or selected and voted on by the natives/people of the Indigenous Community.

Article 3: The Official Code of Conduct for the Imperial Indigenous Marshals shall be Imperial Laws and the Code of Conduct for Law Enforcement Officials guideline of the United Nations, and by the Authority of the Continental Mu'urish Yamaxi Empire Constitutional Monarch and with or without the dictates of the Imperial Indigenous Matriarchal Council.

Article 4: The deputies and guardians of the Imperial Indigenous Marshals shall be selected from among the male nationals of the Continental Mu'urish Yamaxi Empire. The deputies and guardians of the Imperial Indigenous Marshals shall be the male nationals of the CMYE, obtaining the Age of Thirteen (13) to Seventy-Two (72). All deputies of the Imperial Indigenous Marshals, Imperial Community Marshals or Imperial Regional Marshals are conferred with the principle jurisdiction of all Imperial law enforcement functions within the Imperial Empire and the particular office they serve.

- (a) All male nationals of the Continental Mu'urish Yamaxi Empire obtaining the age of sixty-three (63) to age ninety (90) can become a part of the Imperial Indigenous Marshal's Reserve Units.
- (b) All male nationals of the Imperial Indigenous Marshal's regular and reserve units is with the authority to bear arms (i.e. carry a holster and pistol, maintain rifles and other weapons necessary for the safety of all indigenous communities. This authority needs no approval from any outside foreign government or foreign government agent or agencies.
- (c) All male nationals of the Imperial Indigenous Marshals MUST qualify with all weapons of the Imperial Marshal unit each year in regular and/or reserve status.
- (d) Any agent/agency(s) of a foreign government bringing weapons claims against a national of the Imperial Militia Marshal forces (without a dead body or injured by a bullet fired by a national) – without the written complaint of a living man or woman [not in law enforcement] is seen as a breach of the peace and an incident of war.

Article 5: The Imperial Indigenous Marshals will have original jurisdiction within the Continental Mu'urish Yamaxi Empire:

- (a) Of all law enforcement related activities within the Continental Mu'urish Yamaxi Empire.
- (b) Of all criminal complaints made against any national of the Continental Mu'urish Yamaxi Empire by an agency or agent of an alien [USA, Inc., or other foreign] government[s].



- (c) Of all request for information relating to a criminal matter(s) with alien law enforcement agencies or agents of alien governments.
- (d) Of all requests for information relating to a background check from another law enforcement agency or agent from another government as it relates to a national of the Continental Mu'urish Yamaxi Empire. Such request must comply with the requirements of the Imperial Empire Right to Life Policy, and must meet the guidelines of the Universal Declaration of Human Rights.
- (e) No information requested will be sent out without the written authorization of the Continental Mu'urish Yamaxi Empire(s) Chief Law Counsel to the Senior Officer of the Imperial Indigenous Marshal's Liaison Office.
- (f) Any natural member of the Imperial Indigenous Marshal's staff allow in information about a natural member of the Continental Mu'urish Yamaxi Empire to be sent out without authorization, will be charged with a misdemeanor "unauthorized release of information," for a first offense only. Second offense of the same offense will be a felony and will require a court order to settle.
- (g) Anyone allowing information about a natural member of the Continental Mu'urish Yamaxi Empire a third time will be held in custody until a judicial officer can make a decision about the extent of the violation of the rights of the natural member.
- (h) The next office in the line of protection of the rights of any national will be the Imperial Community Marshal who also guard and protect the Imperial CMYE Government Houses.
- (i) The Imperial Community Marshal is the Chief Law Enforcement Officer within the Indigenous Community and is bound by Imperial laws and Natural laws, International laws and Human Rights Instruments for the fundamental freedoms of individuals.
- (j) The Imperial Community Marshal shall determine the number of deputies to be used within the Indigenous Community, by the activities within the Indigenous Community.
- (k) The training of the Imperial Community Marshals will be governed by the imperial law, natural law, international law, human rights instruments, and the fundamental freedoms of individuals.
- (l) The Imperial Community Marshals shall assist the Imperial Regional Marshals in all requests for assistance with imperial court orders, lawful warrant, and escort services.
- (m) The Imperial Indigenous Marshals and Imperial Guardians shall provide official protection, (i.e. bodyguard, perimeter security, vehicle escort,) for all members of the Imperial Royal Family, Imperial Indigenous Matriarchal Council, visiting Heads of State, Ambassadors, Foreign Embassy locations of the Indigenous Nations, and all other Visiting Dignitaries.
- (n) The Imperial Indigenous Marshals and Imperial Guardians shall provide official protection at the habitat of all of the above Dignitaries, whether requested or not. This service will include a full detail of men available for emergency response also.
- (o) The Imperial Indigenous Marshal will provide a "plain clothes division" to be responsible for criminal investigation, background checks, and escort services when requested.
- (p) The Imperial Indigenous Marshals shall maintain a Regional Office, with deputies available to provide backup assistance to all Imperial Community Marshals and Imperial Regional Marshals.



- (q) The Imperial Regional Marshals shall be appointed by the Imperial Indigenous Marshals, but must be approved by the Continental Mu'urish Yamaxi Empire Constitutional Monarch and/or with or without the Imperial Indigenous Matriarchal Council.
- (r) One of the primary duties of the Imperial Regional Marshal is to provide assistance to the Imperial Community Marshal's upon request. Imperial Regional Marshals will also provide patrols on the public highways to assist and protect nationals of the Continental Mu'urish Yamaxi Empire from wrongful accusation by alien forces. All patrols on the public highway will consist of two (2) Imperial Regional Marshals per vehicle.
- (s) All request for information, and/or warrants to be served, must be investigated by the Imperial Community Marshal's Liaison Office and the information passed on to the Imperial Indigenous Marshal's Liaison Office.
- (t) The formal uniform for the Imperial Indigenous Marshal, the Imperial Chief Deputy Marshal, Imperial Guardians Chief Deputy Marshal, Imperial Community Marshal, Imperial Regional Marshal, all Chief Deputy Marshals, all Assistant Chief Deputy Marshals, to the rank of Colonel must wear a black or purple military type shirt, a black waist jacket, with the black pants and black boots. All Officers Colonel and above will wear the rank insignia on the collar of the shirt and on the shoulder lapel of the jacket as designated below.
- (1) The Imperial Indigenous Marshal will display Four Gold Stars on the collar of his shirt and shoulder lapel of the jacket (when worn), with the Imperial seal of his office on the left shoulder and the Imperial National Flag on the right shoulder of the uniform, when wearing the formal uniform.
- (2) The Imperial Chief Deputy Marshal will display Three Gold Stars on the collar of his shirt and shoulder lapel of the jacket (when worn), with the Imperial seal of his office on the left shoulder and the Imperial National Flag on the right shoulder of the uniform, when wearing the formal uniform.
- (3) The Imperial Guardians Chief Deputy Marshal will be of the Imperial Guardians and will display Three Gold Stars on the collar of his shirt and shoulder lapel of the jacket (when worn), with the Imperial seal of his office on the left shoulder and the Imperial Royal Flag on the right shoulder of the uniform for the Imperial Royal Family, when wearing the formal uniform or allow to wear plain clothes, and the Imperial National Flag on the right shoulder of the uniform for the Imperial Indigenous Matriarchal Council, visiting Heads of State, Ambassadors, Foreign Embassy locations of the Indigenous Nations, and all other Visiting Dignitaries.
- (4) The Imperial Community Marshal will display the Three Gold Stars on the collar of his shirt and the shoulder lapel of the jacket (when worn), with the Imperial seal of his office on the left shoulder and the Imperial National Flag on the right shoulder of the uniform, when wearing the formal uniform.
- (5) The Imperial Regional Marshal will display Two Gold Stars on the Collar of his uniform shirt and shoulder lapel of the jacket (when worn), with the Imperial seal of his office on the left shoulder and the Imperial National Flag on the right shoulder of the uniform, when wearing the formal uniform.
- (u) All identity badges of the personnel of the Imperial Indigenous Marshal Office will have the Imperial Indigenous Marshal Imperial seal in the center and the office stamped into the body of the badge.

- (1) All identity cards for Imperial law enforcement personnel will have the Imperial Indigenous Marshal Imperial seal on the background, picture of the individual in the upper right hand corner, with the title of the wearer below the picture.
- (2) All Imperial law enforcement personnel working in "plain clothes," MUST have an identity card affixed to a clip that can identify the individual when in operation with other law enforcement personnel.
- (v) NO Imperial Law Enforcement Official of the Continental Mu'urish Yamaxi Empire-CMYE has the Authority to arrest, detain, or allow any one not associated with the CMYE to arrest or detain any national of the CYYE, upon the request of an agent or agency of another Government or agency acting on behalf of another government, without the Written Authorization of the Chief Imperial Law Counsel of the Imperial Autonomous Autochthon Council for the CMYE.
- (w) NO Imperial Law Enforcement Official of the Continental Mu'urish Yamaxi Empire has the authority to assist, any agent or agency of another Government with the arrest and/or detention of a national of the CMYE without the Written Authorization of the Chief Wazir Imperial Law Counsel of the Imperial Autonomous Autochthon Council-IAAC for the CMYE.
 - (1) Any assistance given in the kidnapping (arrest/detention) of a national of the CMYE without the Written Authority of the Chief Wazir Imperial Law Counsel of the IAAC, is considered TREASON, and will be tried within the Imperial Mu'urish Yamaxi Consular Court-IMYCC of the CMYE.
 - (2) Any law enforcement official found guilty of this crime, will be sentenced to either life without parole, or shot at dawn the following day.
- (x) Imperial law enforcement officials of the Continental Mu'urish Yamaxi Empires' only authority for assisting other agency or agents of a foreign government MUST be in writing from a Imperial Justice of the IMYCC and must be in accordance with imperial laws, natural, international human rights and indigenous rights laws, and the approval of the Liaison Office of the Imperial Indigenous Marshal.

Article 6: This section will identify the office and staff of the Law Enforcement Divisions of the Continental Mu'urish Yamaxi Empire and the role each plays in the overall security of the Empire.

Within the Office of the Imperial Community Marshal Office in the Law Enforcement Division and Detention Divisions, and the Imperial Regional Marshal Office Law Enforcement, Detention and Correctional Divisions, there will be positions for Majors, Captains and Lieutenants.

- e. Majors will command precincts, detention and correctional centers. All Detention Centers will be the responsibility of the Imperial Community Marshals and All Correctional Centers will be the responsibility of the Imperial Regional Marshals.
- f. The Imperial Community Marshals will have responsibility for a Holding Facility to hold detainees that are physically violent, abusive, or is a possible danger to the indigenous community. The maximum time an individual can stay in a Holding Facility is five (5) days the individual must be either sent to a Regional Detention Center on the Order of an Imperial Officer or set free.
- g. Lieutenants will command shifts of the patrol divisions of Imperial Law Enforcement and Departments of Detention Centers and Correctional Centers.
- h. In all Detention and Correctional Centers there must be a Health Inspector (Captain) with duties to insure the general health, welfare of each detainee, and the general overall cleanliness of the facility.
- i. In all Detention and Correctional Centers there must be a Liaison Officer (Captain) to insure the lawful rights of each detainee is of pari-mount interest to all officers and supervisors of the Center.
- j. The Reporting Authority for both the Health Inspector and the Liaison Officer is the Imperial Community Marshal's Office. All reports of negative action by the staff of a Detention Center will have an investigator from the Imperial Community Marshal's Office investigate all such incidents.

- k. All reports of Center Staff not following guidelines as set by the Imperial Indigenous Matriarchal Council, with the recommendation of the investigator from the Imperial Indigenous Marshal 's Office and the results sent in a report to the Imperial Community Justice Marshal's Office of Law.

Article 7: All rank displayed on the collar of all Imperial Officers of the Imperial Law Enforcement Departments of the Continental Mu'urish Yamaxi Empire will be "gold" and All badges of the Imperial Officers and Supervisors will be "gold" - NO EXCEPTION.

Article 8: All Imperial Officers of the Law Enforcement Departments of the Continental Mu'urish Yamaxi Empire will wear the military style headgear. The Imperial Indigenous Marshals, Imperial Community Marshals, Imperial Regional Marshals, all Chief Deputies, and Assistant Chief Deputies will wear the headgear with the "gold leaf" on the front.

Article 9: For every Imperial Indigenous Marshal, Imperial Guardian, Imperial Community Marshal, Imperial Regional Marshal, Chief Deputy Marshal, and Assistant Chief Deputy Marshal, there must be an assistant that has the responsibility to ensure the operation is running smoothly while the Chief Officer is busy within the political arena.

- a) This Office will be manned by a Sergeant, empowered with the authority to ensure all orders of the Chief Officer is understood by the least of the Imperial officers within the law enforcement community of the CMYE.
- b) In the Office of the Imperial Indigenous Marshal, there will be a Chief Master Sergeant. The emblem for the Chief Master Sergeant will be three stripes up, three stripes down, with two small stars with a wreath on the bottom of the stars.
- c) The next position in the line of progression will be the Senior Chief Master Sergeant. The emblem for the Senior Chief Master Sergeant will be three stripes up, three stripes down, with one small star with a wreath on the bottom of the star.
- d) The next position in the line of progression will be the Master Sergeant. The emblem for the Master Sergeant will be three stripes up, three stripes down, with a star in the middle.
- e) The next position in the line of progression will be the First Sergeant. The emblem for the First Sergeant will be three stripes up and three stripes down.
- f) The next position in the line of progression will be the Patrol Sergeant. The emblem for the Patrol Sergeant will be three stripes up and two stripes down.
- g) The next position in the line of progression will be the Shift Sergeant. The emblem for the Shift Sergeant will be three stripes up and one stripe down.
- h) The next position in the line of progression will be the Street Supervisor. The emblem for the Street Supervisor will be three stripes down and three stripes up.
- i) The next position in the line of progression will be the Street Sergeant. The emblem for the Street Sergeant will be three stripes down and two stripes up.
- j) The next position in the line of progression will be the Field Training Officer. The emblem for the Field Training Officer will be two stripes down, one stripe up, with a diamond in the middle.

- k) There will be only one Chief Master Sergeant. This position will be in the Office of the Imperial Indigenous Marshals only. The job of the Chief Master Sergeant will be to inspect the records of the Sergeants below his position, to ensure the deputies within the law enforcement departments are receiving training in imperial law, natural law, indigenous rights, human rights requirements, and all updates as warranted.
- l) The position of Senior Chief Master Sergeant will be in all Imperial Community Marshal Offices. Their jobs will be the same as the Chief Master Sergeant, but on the lower level, and to keep the Imperial Indigenous Marshal Chief Deputy, updated on the progress of all personnel within the command.
- m) The position of Master Sergeant will be in the Offices of the Imperial Regional Marshal Chief Deputy, and all Imperial Indigenous Marshal Assistant Chief Deputy Offices. Their jobs are the same as the positions above them, in respect to their office.
- n) The position of First Sergeant will be in the Offices of the Imperial Community Marshal Assistant Chief Deputy and Imperial Regional Marshal Assistant Chief Deputy.
- o) The position of Patrol Sergeant will be mainly in the law enforcement divisions of the Imperial Regional Marshal Offices, and the law enforcement and detention divisions of the Imperial Community Marshal Offices, as well as all sergeant positions, (Shift Sergeant, Street Supervisor, Street Sergeant, Field Training Officer), below it.

Article 10: This section contains the Imperial Law requirements of the Imperial Law Enforcement Departments of the Continental Mu'urish Yamaxi Empire.

b2)

The Imperial Indigenous Marshals

Article 1:

Imperial law enforcement officials shall at all times fulfill the duty imposed upon them by imperial law, by serving the indigenous community and by protecting all natives/people against illegal acts, consistent with the high degree of responsibility required by their profession.

Commentary:

- (a) The term "Imperial law enforcement officials", includes all officers/deputies of the imperial law, whether appointed or elected, who exercise constable powers, especially the powers of investigation, arrest, or detention.
- (b) In countries where constable powers are exercised by military authorities, whether uniformed or not, or by State security forces, the definition of law enforcement officials shall be regarded as including imperial officers of such services.
- (c) Service to the indigenous community is intended to include particularly the rendition of services of assistance to those members of the indigenous community who by reason of personal, economic, social or other emergencies are in need of immediate aid.
- (d) This provision is intended to cover not only all violent, predatory and harmful acts, but extends to the full range of prohibitions under penal imperial laws. It extends to conduct by persons not capable of incurring criminal liability.

Article 2:

In the performance of their duty, imperial law enforcement officials shall respect and protect human dignity and maintain and uphold the human rights of all persons.

Commentary:

- (a) The human rights in question are identified and protected by Imperial law, and international law. Among the relevant international instruments are the Universal Declaration of Human Rights, the International Covenant on Civil and Political Rights, the Declaration on the Protection of All Persons from Being Subjected to Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment, the United Nations Declaration on the Elimination of All Forms of Racial Discrimination, the International Convention on the Elimination of All Forms of Racial Discrimination, the International Convention on the Suppression and Punishment of the Crime of Apartheid, the Convention on the Prevention and Punishment of the Crime of Genocide, the Standard Minimum Rules for the Treatment of Prisoners and the Vienna Convention on Consular Relations.
- (b) National commentaries to this provision should indicate regional or national provisions identifying and protecting these rights.

Article 3:

Imperial law enforcement officials may use force only when strictly necessary and only that which is necessary to the extent required for the performance of their duty.

Commentary:

- (a) This provision emphasizes that the use of force by imperial law enforcement officials should be exceptional; while it implies that imperial law enforcement officials may be authorized to use force as is reasonably necessary under the circumstances for the prevention of crime or in effecting or assisting in the lawful arrest of offenders or suspected offenders, no force going beyond that may be used.
- (b) National law ordinarily restricts the use of force by imperial law enforcement officials in accordance with a principle of proportionality. It is to be understood that such national principles of proportionality are to be respected in the interpretation of this provision. In no case should this provision be interpreted to authorize the use of force which is disproportionate to the legitimate objective to be achieved.
- (c) The use of firearms is considered an extreme measure. Every effort should be made to exclude the use of firearms, especially against children. In general, firearms should not be used except when a suspected offender offers armed resistance or otherwise jeopardizes the lives of others and less extreme measures are not sufficient to restrain or apprehend the suspected offender. In every instance in which a firearm is discharged, a report should be made promptly to the competent authorities.

Article 4:

Matters of a confidential nature in the possession of imperial law enforcement officials shall be kept confidential, unless the performance of duty or the needs of justice strictly require otherwise.

Commentary:

By the nature of their duties, imperial law enforcement officials obtain information which may relate to private lives or are potentially harmful to the interests, and especially the reputation,

of others. Great care should be exercised in safeguarding and using such information, which should be disclosed only in the performance of duty or to serve the needs of justice. Any disclosure of such information for other purposes is wholly improper.

Article 5:

No imperial law enforcement official may inflict, instigate or tolerate any act of torture or other cruel, inhuman or degrading treatment or punishment, nor may any law enforcement official invoke superior orders or exceptional circumstances such as a state of war or a threat of war, a threat to national security, internal political instability or any other public emergency as a justification of torture or other cruel, inhuman or degrading treatment or punishment.

Commentary:

(a) This prohibition derives from the Declaration on the Protection of All Persons from Being Subjected to Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment, adopted by the General Assembly, according to which: "[Such an act is] an offence to human dignity and shall be condemned as a denial of the purposes of the Charter of the United Nations and as a violation of the human rights and fundamental freedoms proclaimed in the Universal Declaration of Human Rights [and other international human rights instruments]."

(b) The Declaration defines torture as follows: ". . . torture means any act by which severe pain or suffering, whether physical or mental, is intentionally inflicted by or at the instigation of a public official on a person for such purposes as obtaining from him or a third person information or confession, punishing him for an act he has committed or is suspected of having committed, or intimidating him or other persons. It does not include pain or suffering arising only from, inherent in or incidental to, lawful sanctions to the extent consistent with the Standard Minimum Rules for the Treatment of Prisoners."

(c) The term "cruel, inhuman or degrading treatment or punishment" has not been defined by the General Assembly but should be interpreted so as to extend the widest possible protection against abuses, whether physical or mental.

Article 6:

Imperial law enforcement officials shall ensure the full protection of the health of persons in their custody and, in particular, shall take immediate action to secure medical attention whenever required.

Commentary:

(a) "Medical attention", which refers to services rendered by any medical personnel, including certified medical practitioners and paramedics, shall be secured when needed or requested.

(b) While the medical personnel are likely to be attached to the imperial law enforcement operation, imperial law enforcement officials must take into account the judgment of such personnel when they recommend providing the person in custody with appropriate treatment through, or in consultation with, medical personnel from outside the imperial law enforcement operation.

(c) It is understood that imperial law enforcement officials shall also secure medical attention for victims of violations of imperial law or of incidents occurring in the course of violations of Imperial law.

Article 7:

Imperial law enforcement officials shall not commit any act of corruption. They shall also rigorously oppose and combat all such acts.

Commentary:

- (a) Any act of corruption, in the same way as any other abuse of authority, is incompatible with the profession of imperial law enforcement officials. The imperial law must be enforced fully with respect to any imperial law enforcement official who commits an act of corruption, as Governments cannot expect to enforce the law among their nationals and citizens if they cannot, or will not, enforce the law against their own agents and within their agencies.
- (b) While the definition of corruption must be subject to imperial law, and national law, it should be understood to encompass the commission or omission of an act in the performance of or in connection with one's duties, in response to gifts, promises or incentives demanded or accepted, or the wrongful receipt of these once the act has been committed or omitted.
- (c) The expression "act of corruption" referred to above should be understood to encompass attempted corruption.

Article 8:

Imperial law enforcement officials shall respect the Imperial Law and the present Code. They shall also, to the best of their capability, prevent and rigorously oppose any violations of them. Imperial law enforcement officials who have reason to believe that a violation of the present Code has occurred or is about to occur shall report the matter to their superior authorities and, where necessary, to other appropriate authorities or organs vested with reviewing or remedial power.



Commentary:

- (a) This Code shall be observed whenever it has been incorporated into national legislation or practice. If legislation or practice contains stricter provisions than those of the present Code, those stricter provisions shall be observed.
- (b) The article seeks to preserve the balance between the need for internal discipline of the agency on which public safety is largely dependent, on the one hand, and the need for dealing with violations of basic human rights, on the other. Imperial law enforcement officials shall report violations within the chain of command and take other lawful action outside the chain of command only when no other remedies are available or effective. It is understood that imperial law enforcement officials shall not suffer administrative or other penalties because they have reported that a violation of this Code has occurred or is about to occur.
- (c) The term "appropriate authorities or organs vested with reviewing or remedial power" refers to any authority or organ existing under imperial law, and national law, whether internal to the imperial law enforcement agency or independent thereof, with statutory, customary or other power to review grievances and complaints arising out of violations within the purview of this Code.
- (d) In some countries, the mass media may be regarded as performing complaint review functions similar to those described in subparagraph (c) above. Imperial law enforcement officials may, therefore, be justified if, as a last resort and in accordance with the laws and customs of their own countries and with the provisions of Article 4 of the present Code, they bring violations to the attention of public opinion through the mass media.

(e) Imperial law enforcement officials who comply with the provisions of these Codes deserve the respect, the full support and the co-operation of the indigenous community and of the law enforcement agency in which they serve, as well as the law enforcement profession.

c) For the knowing by all Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire that the Imperial Guardians under the leading of the Continental Mu'urish Yamaxi Empire Constitutional Monarch: will be the Trained and Trusted Security of the Continental Mu'urish Yamaxi Empire Reigning Monarch and are responsible for upholding, enforcing and practicing all aspects of Air-AIR, Land-LAND, Law-LAW, and Water-Water. The mission of the Imperial Guardians is to safeguard and protect the Imperial Royal House of Emperor-Monarch-[NR]: Sambhu Re  and the Emperor-Monarch Immediate Royal Family; and the Empire's financial infrastructure and payment systems while preserving the integrity of the Empire/Kingdom. The Imperial Guardians duties also include protection for the following: Imperial Indigenous Matriarchal Council, Ambassador and Chief Deputy Ambassador of the Imperial Royal Embassies, Deputy Ambassador and Consuls of the Imperial Mu'urish Yamaxi Consulates; The Imperial Chancellor and Imperial Deputy Chancellor, visiting Heads of State, Foreign Embassy locations of the Indigenous Nations, and all other Visiting Dignitaries and individuals as designated per Imperial Executive Order from Imperial Royal House of Emperor-Monarch-[NR]: Sambhu Re ; also the immediate families of the above individuals.

For the Preservation, Equalization and Cultivation of the Continental Mu'urish Yamaxi Empire: all Imperial Houses must follow the documentation and operational protocols established by the Imperial Indigenous Matriarchal Council.

d) For the knowing by all Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire that the Imperial Indigenous Matriarchal Council under the leading of the Continental Mu'urish Yamaxi Empire Constitutional Monarch: will be the Head of the Continental Mu'urish Yamaxi Empire Imperial Central Government.

- 1) It is the duty of the Imperial Indigenous Matriarchal Council of Thirty One(31) to represent the natives/people in Imperial Affairs;
- 2) Act as a part of the Imperial Mu'urish Yamaxi Consular Court, Imperial National Law Tribunals division for tribal affairs and disputes among indigenous communities, tribes and clans of the CMYE ;
- 3) In all tribal affairs and disputes a tribunal will consist of one (1) Chief Justice of Imperial supreme Court as head of the tribunal and eight (8) Imperial Indigenous Matriarchal Council members;
- 4) To Oversee the Security and Infra-Structures of the Continental Mu'urish Yamaxi Empire, and
- 5) Work with Governments of other Nations on concluding Treaties with foreign powers on behalf of the Imperial Royal Crown and to ensure peace for all mankind.



The Nationals of the Imperial Indigenous Matriarchal Council will be selected by vote, their will be an 'One Imperial Secretary General', 'One Imperial Chief Deputy Secretary General' and 'One Imperial Deputy Secretary General'.

- 6) The nationals serving in these posts will serve for five (5) years.
- 7) May receive votes for a second term.
- 8) But can only serve two terms in a thirteen (13) year period.
- 9) Nationals leaving these posts must wait at least eight (8) years before becoming eligible for another vote to this post.

10) All Members of the Imperial Indigenous Matriarchal Council will serve a term of natural life as an Imperial Indigenous Matriarch of the Council.

e) For the knowing by all the Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire that His Imperial Majesty's Royal Post  under the leading of the Continental Mu'urish Yamaxi Empire Constitutional Monarch: are responsible for universal mail collection and delivery within the Continental Mu'urish Yamaxi Empire and is the Imperial Royal Post Office of the Continental Mu'urish Yamaxi Empire. The Imperial Royal Post Office is a system for transporting letters and other tangible objects: written documents; typically enclosed in envelopes, and also small and large packages delivered to destinations around the world. Security for His Imperial Majesty Royal Post  is the responsibility of the Imperial Postal Inspectors.

f) For the knowing by all the Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire that the Imperial Mu'urish Yamaxi Consular Court under the leading of the Continental Mu'urish Yamaxi Empire Constitutional Monarch: is the Continental Mu'urish Yamaxi Empire Judiciary House. The Imperial Mu'urish Yamaxi Consular Court functions to interpret the Imperial law; determine the Constitutionality of Imperial law pertaining to Imperial Constitution of the Continental Mu'urish Yamaxi Empire, and also applies the Imperial law to individual cases. The Imperial Courts can compel the production of evidence and testimony through the use of subpoenas, and adjudicate civil matters in commerce and crimes involving nationals as well as violations against the Imperial Constitution of the CMYE.

Article 1: Imperial Mu'urish Yamaxi Consular Court Judicial System

The Imperial Mu'urish Yamaxi Consular Court Judicial System of the Continental Mu'urish Yamaxi Empire will have a Imperial supreme Court and Inferior Courts as the need arises for Claims.

- a) There will be an Imperial National Court of Appeal that is second to the Imperial supreme Court.
- b) There will be an Imperial National Law Tribunal with locations in every Region.
 - 1) Imperial National Law Tribunals will hear disputes of individual parties from different indigenous communities, tribes and clans.
 - 2) The Imperial National Law Tribunals division for tribal affairs and disputes among indigenous communities, tribes and clans will be part of the Imperial Indigenous Matriarchal Council.
 - 3) Imperial National Law Tribunals will also hear disputes from foreign governments and/or foreign agents making claims against individual nationals/members and businesses of the Continental Mu'urish Yamaxi Empire.
- c) There will be an Imperial Regional Law Tribunal to hear cases involving major crimes i.e. assaults, major theft, kidnapping, homicide, and other felonies and civil cases with a value of more than Five Thousand Dollars in Gold (\$5,000.00).
- d) There will be a Imperial Community Law Tribunal in each Indigenous Community of the CMYE that will hear minor disputes between nationals/members of the indigenous communities, request for felony warrants, and civil cases with a value less than Five Thousand Dollars in Gold up to Four Thousand Nine Hundred Ninety Nine Dollars and Ninety Nine Cents in Gold (\$4,999.99).

Article 2: Imperial supreme Court

The Imperial supreme Court will have nine (9) Master Justices of Imperial Law.

- a) The Imperial supreme Court will hear appeals from the Imperial National Court of Appeals, and claims from Foreign Governments, Foreign Nationals and Businesses against a National or Member or Business of the CMYE, and violations of Imperial Laws of the Imperial Constitution of the Continental Mu'urish Yamaxi Empire, Natural Law, or Treaties of the CMYE.
- b) There will be four (4) Reserve Master Justices of Imperial Law for the Imperial supreme Court.
- c) There will be One Imperial National Law Tribunal that will consist of one (1) Chief Justice from the Imperial supreme Court appointed from Section b) of this Article.
- d) There is no set time for the Imperial supreme Court to meet except when necessary by Imperial Law.
- e) The Imperial supreme Court will have a Chief Clerk of Record to accept and schedule appeals and claims.
- f) At all times when the Imperial supreme Court convenes, there will be at least Nine Marshals from the Imperial Indigenous Regional Marshal Office present.

Article 3: Imperial National Court of Appeals

The Imperial National Court of Appeals will have seven (7) Senior Justices of Imperial Law to hear appeals from either the Imperial National Law Tribunals or Imperial Regional Law Tribunals.

- a) There will be four (4) Reserves Senior Imperial Law Justices for the Imperial National Court of Appeals.
- b) The Imperial National Court of Appeals will schedule meetings during the Second and Fourth Weeks of each Month.
- c) Any additional time for Appeals will be at the discretion of the Senior Justices of Imperial Law.
- d) It takes a minimum of three (3) Senior Justices of Imperial Law to give a valid decision in any case before the Imperial National Court of Appeals.
- e) The meetings of the Imperial National Court of Appeals will have at least five (5) Marshals from the Imperial Indigenous Regional Marshal's Office.
- f) The Imperial National Court of Appeals will have a Chief Clerk of Record to accept and schedule all Appeals.
- g) The Imperial National Court of Appeals will hear only claims of violations of Imperial Laws of the Imperial Constitution of the Continental Mu'urish Yamaxi Empire, Natural Law, or Treaties of the Continental Mu'urish Yamaxi Empire.

Article 4: Imperial National Law Tribunals

Each Imperial National Law Tribunal will have five (5) Senior Justices of Imperial Law to hear disputes within its Region of assignment.

- a) There will also be three (3) Reserve Senior Justices of Imperial Law for each Imperial National Law Tribunal.
- b) The place for all meetings of the Imperial National Law Tribunals will have the consideration of both the Imperial Regional and Imperial Indigenous Marshal's Offices.
- c) All times for parties of a civil dispute will be at a time for at least three (3) Imperial Regional Marshals to be present.
- d) All parties to a criminal claim will appear during the first and third Monday through Wednesday of each month.

- e) All times for parties of criminal disputes will be at a time for at least seven (7) Imperial Regional Marshals to be present.
- f) Any additional time will be at the discretion of the Senior Justices of Imperial Law.
- g) There will be an Imperial National Law Tribunal Chief Clerk of Record to accept and schedule all disputes and claims.

Article 5: Imperial Regional Law Tribunals

Each Imperial Regional Law Tribunal will have three (3) Justices of Imperial Law to hear disputes within the Region.

- a) There will also be two (2) Reserve Justices of Imperial Law for the Imperial Regional Law Tribunal.
- b) The place for all meetings of the Imperial Regional Law Tribunal will be at the discretion of the Imperial Regional Marshal.
- c) All times for parties of a civil dispute will be at a time for at least two (2) Imperial Regional Marshals to be present.
- d) All parties to a criminal claim will appear during the second Tuesday through Friday of each month.
- e) All times for criminal claims will be at a time for at least five (5) Imperial Regional Marshals to be present.
- f) Any additional time will be at the discretion of the Justices of Imperial Law.
- g) The Imperial Regional Law Tribunal will have a Chief Clerk of Record to accept and schedule all disputes and claims.

Article 6: Imperial Community Law Tribunals

Each Imperial Community Law Tribunal will have two (2) Justices of Imperial Law and one (1) Reserve Justice of Imperial Law to hear disputes within that Indigenous Community.


- a) The place for all meetings of the Imperial Community Law Tribunals will be at the discretion of the Imperial Regional Marshal.
- b) All times for parties of a dispute to appear before the Imperial Community Law Tribunal must be at a time for at least three (3) Imperial Regional Marshals to be present.
- c) The Imperial Community Law Tribunal will have a Chief Clerk of Record to accept and schedule all disputes and request for warrants.

Article 7: Parties bringing Claims within the Tribunals of the Imperial Mu'urish Yamaxi Consular Court Judicial System


- a) All parties bringing a claim before any of the Tribunals within the Imperial Mu'urish Yamaxi Consular Court Judicial System for the Continental Mu'urish Yamaxi Empire must have the capacity to present the facts of the case in persona as a victim.
- b) At no time can a party have someone 'represent' them for any reason, except as may be the Order of the Tribunal per Section d) of this Article.
- c) All Imperial Law Counsels must follow the guidelines of Article 7 of this Imperial Constitution or be given another assignment.
- d) Imperial Justices of Imperial Law may in times - (1) when the victim is a minor child, - (2) a party is said to be mentally incompetent to speak, - (3) a party is not medically able to speak, - (4) a dispute between siblings of an estate without a will or trust, (5) assign a Imperial Law Counsel to investigate the claim and make a report to the Tribunal.



e) After receiving a report ask for by an Imperial Justice of Imperial Law, the Imperial Justice then makes a decision as to the continuation of the claim.

g) For the knowing by all the Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire that the Imperial CMYE Treasury under the leading of the Continental Mu'urish Yamaxi Empire Constitutional Monarch: is responsible for promoting economic prosperity and ensuring the financial security of the Continental Mu'urish Yamaxi Empire. The Imperial CMYE Treasury is the holding house for all the Continental Mu'urish Yamaxi Empire Platinum, Gold, Silver and other Precious Metals and stones. One of the Imperial CMYE Treasury's missions is to maintain a strong economy for the Empire by creating economic and commercial opportunities. This will be done by promoting the conditions that enable economic growth and stability at home and abroad. This will also strengthen the security of the Continental Mu'urish Yamaxi Empire by combating threats and protecting the integrity of the financial system. The Imperial CMYE Treasury's mission also highlights its role as the steward of CMYE economic and financial systems, and as an influential participant in the global economy, advising the Imperial Royal House of Emperor-Monarch-INRI: Sambhu Re  on economic and financial issues, encouraging sustainable economic growth, and fostering improved governance of the Imperial Bennu Global Financial Institution.

h) For the knowing by all Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire that the Imperial House of Viziers under the leading of the Continental Mu'urish Yamaxi Empire Constitutional Monarch: are visionary's appointed by Reigning Monarch to be advised on all aspects.

i) For the knowing by all Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire that the Imperial Royal Embassy under the leading of the Continental Mu'urish Yamaxi Empire Constitutional Monarch: came into existence on Thursday, November 1, 2012, A.D., by an Emperor's Directive, and was enacted for the Continental Mu'urish Yamaxi Empire by Emperor-Monarch-INRI: Sambhu Re , Droit!

Executive Houses:

The most important of these is maintaining price stability and supporting the economic policies of the Continental Mu'urish Yamaxi Empire thus promoting economic growth. There are two (2) main areas which are tackled by the Imperial Benu Global Financial Institution to ensure it carries out these functions efficiently:

Monetary Stability -

Stable prices and confidence in the currency are the two main criteria for monetary stability. Stable prices are maintained by making sure price increases meet the CMYE Government's inflation target. The Imperial Autonomous Autochthon Council is committed to the ongoing application and comprehension of the science of Imperial Law: Natural Law, Law of the Land, and Law of the Seas as it relates to nationals of the Continental Mu'urish Yamaxi Empire/Mu'urish Yamaxi American Natives-Olmec Civilization.

Article 1: Duties of Imperial Law Counsels

- a) Any man or woman given the Title of Imperial Law Counsel **MUST** complete an initial course with a basic understanding of Imperial Laws, Natural Laws, Covenants and Commandments, International Laws, Human Rights Laws, Rule of Evidence, and follow other guidelines as the need arises.
- b) No Imperial Law Counsel can 'represent' any one in a Tribunal of Imperial Law within the CMYE.
- c) Any Imperial Law Counsel attempting to represent any one without the consent or order of the Justice, will go through more training before coming into any Tribunal of the Imperial Mu'urish Yamaxi Consular Court Judicial System again.
- d) Imperial Law Counsels may 'assist' nationals of the CMYE with the format of a claim,
- e) notes of bringing a claim,
- f) procedures of the Tribunal, and
- g) investigating any claims given by a Justice of Imperial Law in a Tribunal where the request for additional information is of necessity to a formal Judgment of Imperial Law.
- h) Imperial Law Counsels will also have the responsibility of teaching classes on Imperial Law to nationals in the Indigenous Communities, Tribes and Clans of their assignment.

n) For the knowing by all the Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire that the Imperial House of Health & Wellness under the leading of the Continental Mu'urish Yamaxi Empire Constitutional Monarch: know that as a race of natives/people we have been robbed, raped, mis-educated, beaten, mis-trusted, infamously stereotyped, maliciously hung, secretly glorified, intentionally damaged, massively molested, fooled, categorically punished, sunken into destructive habits willingly, vehemently abused, emotionally damaged, and the list continues! Re-introducing knowledge on re-leasing, cleansing, healing and fine tuning of our nationals' inner and outer selves is paramount in order to properly function and re-align to our true self. The mission is protecting the Health and Wellness of all Mu'urish Yamaxi American Natives-Olmec Civilization, providing essential human services, as well as regulating and certifying: commercial eateries; water, food and herbal distribution; and healing/balancing facilities. Improving the health, safety, and well-being of all Mu'urish Yamaxi American Natives-Olmec Civilization of all ages in ways that will expedite the necessary healing/balancing for all! The Imperial House of Health and Wellness is aimed at preventing disease (dis ease) with sound right reasoning and the science of our indigenous ancestors of re-storing proper balance to the mind, body, spirit and soul with certified state-of-the art healing centers and balancing facilities. "Every ant knows the formula of its ant hill, every bee knows the formula of its beehive, they know it in their own way, not in our way, only humankind does not know its formula" ~ Fyodor Dostoyevsky. Exposing nationals to "our way" the ancient formula to conquer death and achieve universal balance.

o) For the knowing by all the Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire that the Imperial Community Marshals under the leading of the Continental Mu'urish Yamaxi Empire Constitutional Monarch: are responsible for the safety of the Indigenous Communities, Tribes and Clans that they represent as well as making sure that certain security and notifications occur in their indigenous community area as it relates to Mu'urish Yamaxi American Native-Olmec Civilization Nationals; such as carrying out court orders for the areas that they preside over. The Imperial Community Marshals will guard and protect the Imperial CMYE Government Houses and are responsible for upholding, enforcing and practicing all aspects of Law-LAW, Land-LAND, Air-AIR, and Water-WATER. They maintain the peace in the indigenous community that they represent by being elected and maintaining the trust of the

In addition, moral principles, integrity and equality are intricate ingredients that are in both the professional and personal life of the Imperial Community Marshal Official. As Role Models, we value respect, honoring the rights and dignity of each native we are called upon to serve and protect.

p) For the knowing by all Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire that the Imperial Regional Marshals under the leading of the Continental Mu'urish Yamaxi Empire Constitutional Monarch: are the Imperial Marshals of the Imperial Mu'urish Yamaxi Consular Court for the CMYE and are responsible for upholding, enforcing and practicing all aspects of Law-LAW, Land-LAND, Air-AIR, and Water-WATER. The Imperial Constitution of the Continental Mu'urish Yamaxi Empire specifically grants the Imperial Regional Marshals Authority, while the Imperial Indigenous Marshal's institutes the conditions on which the Imperial Regional Marshals operate within the Imperial Mu'urish Yamaxi Consular Court.

The head of the Imperial Regional Marshals is the Chief Officer of the Imperial Regional Marshals and the external communicators for the Executive Houses and Imperial CMYE Government Houses and serves as the Custodian and Messenger for the Imperial Mu'urish Yamaxi Consular Court. To serve as an Imperial Regional Marshal Chief Officer or Imperial Chief Officer from the Imperial Indigenous Marshals, Imperial Guardians or Imperial Community Marshals, one must take an Oath of Office and be bonded upon taking office to ensure the faithful performance of the duties of the office. In addition, moral principles, integrity and equality are intricate ingredients that are in both the professional and personal life of the High Official as well as those appointed to assist. As Role Models, we value respect, honoring the rights and dignity of each person we are called upon to serve.

Nobody is above the Law-L.A.W.! The Imperial Constitution of the Continental Mu'urish Yamaxi Empire clearly limits government authority and defines the authority that "The Indigenous Natives/People" of the Continental Mu'urish Yamaxi Empire have given to it. The Imperial Regional Marshals are committed to its Constitutional Authority to effectively and efficiently manage: court services; the correctional facility; the execution of processes, orders and judicial notices of the courts; the preservation of the peace.

Imperial CMYE Government Houses:

q) For the knowing by all the Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire that the Imperial Chancellor under the leading of the Continental Mu'urish Yamaxi Empire Constitutional Monarch: is the Executive power of the Imperial CMYE Government and leads the Imperial CMYE Government of the Continental Mu'urish Yamaxi Empire; The Chancellor is charged with: the Execution of Imperial Protocols for the Imperial CMYE Government, alongside the responsibility of appointing Executives for the Imperial CMYE Government; the Chancellor also acts as the public "face" and "voice" of the Imperial CMYE Government, both at home and abroad. In addition, provides the governing mandates of the Imperial CMYE Governmental Houses; including but not limited to devising strategic missions, overseeing tactical plans and approving operational budgets in order to ensure organizational alignment. Imperial Chancellor Terms of office: There shall be an Imperial Chancellor who shall hold office for a term of five (5) years and until a successor shall be chosen and qualified. Nationals holding the office of Imperial Chancellor shall not again be eligible to be elected to that office until after the expiration of five (5) years from the conclusion of their term as Imperial Chancellor and shall commence on the first day after their election and continue until their successors are elected and qualified.



- 1) Imperial Deputy Chancellor: There shall be an Imperial Deputy Chancellor, who shall be elected at the same time, for the same term, and in the same manner as the Imperial Chancellor.
- 2) Succession as Imperial Chancellor: The Imperial Deputy Chancellor-elect shall become Imperial Chancellor upon the failure of the Imperial Chancellor-elect to qualify. The Imperial Deputy Chancellor shall become Imperial Chancellor upon the death, resignation, or removal from office of the Imperial Chancellor. The further order of succession to the office of Imperial Chancellor shall be prescribed by Imperial Law.
- r) For the knowing by all the Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire that the Imperial House of Energy under the leading of the Continental Mu'urish Yamaxi Empire Constitutional Monarch: is responsible for domestic energy production, scientific research and energy-related research such as Biological and Environmental Research Workforce Development for Teachers and Scientists; also development in the fields of energy efficiency and renewable energy technologies that will diminish the human affect on the Planet, and supply Clean, Reliable and affordable Energy Technologies to the marketplace; and advance the everyday lives of Mu'urish Yamaxi American Natives-Olmec Civilization by enhancing their energy choices and their quality of life.
- s) For the knowing by all the Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire that the Imperial House of Agriculture under the leading of the Continental Mu'urish Yamaxi Empire Constitutional Monarch: is responsible for Developing and Executing Policies on Farming, Agriculture, and Food! It aims to meet the needs of farmers and ranchers, promote agricultural trade and production, and work to assure food safety, protecting natural resources, communication fostering rural communities and investigating channels to end hunger.
- t) For the knowing by all the Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire that the Imperial House of Commerce under the leading of the Continental Mu'urish Yamaxi Empire Constitutional Monarch: is responsible for Creating an Infrastructure that promotes Economic Growth, Technological Competitiveness, Sustainable Development, as well as procures economic and demographic data. The Imperial House of Commerce-also facilitates Business Revenue Streams in matters of Trade, Industry, Production and Marketing. The Imperial House of Commerce will also provide a barter-trade network for the Continental Mu'urish Yamaxi Empire Nationals.
- u) For the knowing by all the Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire that the Imperial I-Em-Hutip University under the leading of the Continental Mu'urish Yamaxi Empire Constitutional Monarch: is the Continental Mu'urish Yamaxi Empire Learning Institution. It is an evolving entity designed to educate and train, Infants/Toddlers, Children, Teenagers and Adults; with proven facts to Gain Knowledge in Science, Health Nutrition, Medicine, Natural Healing, supreme Mathematics, Law, Language, Literature, Business, etc... May the ancient/indigenous ones grant the Mu'urish Yamaxi American Natives-Olmec Civilization the courage to change the things we can change, the tranquility to accept those we cannot change, and the right wisdom, right knowledge, right over standing and sound right reasoning to know the difference.
- v) For the knowing by all the Continental Mu'urish Yamaxi Empire Nationals of the Continental Mu'urish Yamaxi Empire that the Imperial House of Communication under the leading of the Continental Mu'urish Yamaxi Empire Constitutional Monarch: is a unique community of professionals responsible for the implementation and/or management of all CMYE communication networks as well as the internal and external flow of information. The Imperial House of Transportation also partners with national and international organizations in order to provide the most appropriate travel means for Mu'urish Yamaxi American Natives-Olmec Civilization Nationals. The right for a Mu'urish Yamaxi American Natives to travel or transport his/her property upon the national and international; public highways, byways and/or waterways thereon, either by automobile, boat, or air is hereby governed by the Imperial House of Transportation. The Imperial House of Transportation also is responsible for registration, management and distribution of all identification numbers for vehicles (car, boat, truck, planes, etc...).

Section 5:

Section 1:

We, Autonomous Autochthon Mu'urish Yamaxi American Natives-Olmec Civilization, as well as each Human have a Natural Right to Food, Water, Clothing, Natural Healing, Education-Learning, Shelter, Medical Assistance, and Dental Assistance, for in any society this is Humane; for the knowing by all Autonomous Autochthon Mu'urish Yamaxi American Natives.

Imperial Law 13: Protection

Be it enacted by Emperor-Monarch-[NR]: Sambhu Re :

Section 1:

We, Autonomous Autochthon Mu'urish Yamaxi American Natives-Olmec Civilization, have the Right to take the necessary means within our own Imperial Laws, as she or he sees fit to be secure in our beings as well as our Property, Families, Friends, and Personal Effects, and to our right to keep and Bear Arms on our Being as well as on our own Property.

Section 2:

We, Autonomous Autochthon Mu'urish Yamaxi American Natives-Olmec Civilization have the inalienable right to our Territories, Space, Air, Land and Sea.

Imperial Law 14: Legal Matters

Be it enacted by Emperor-Monarch-[NR]: Sambhu Re :

Section 1:

For all legal matters, a national of the Continental Mu'urish Yamaxi Empire cannot be accused or held for an abuse of a political rules such as the Uniform Commercial Code , or any other rules of another Nation. Mu'urish Yamaxi American Natives-Olmec Civilization and other nations and peoples should take effective legislative, administrative, judicial, tribal or other measures to prevent acts of suffering in any territory under our jurisdiction.

Indigenous Mu'urish Yamaxi American Natives-Olmec Civilization are natural individuals who must follow the only true laws, that being Natural Law and Imperial Law!

Imperial Law 15: Travel

Be it enacted by Emperor-Monarch-[NR]: Sambhu Re :

Section 1:

All nationals of the Continental Mu'urish Yamaxi Empire/Mu'urish Yamaxi American Natives-Olmec Civilization being natural individuals and "Indigenous Natives/People", and are not subject to any political rules of any other nation, reserves all natural rights to travel the roadways, highways, byways, waterways, and airways unhindered.

Be it enacted by Emperor-Monarch-[NR]: Sambhu Re 

Section 1:

All Nationals of the Continental Mu'urish Yamaxi Empire/Mu'urish Yamaxi American Natives-Olmec Civilization, the "Indigenous Natives/People" of this hemisphere, hereby reserves our inalienable rights to educate ourselves, meaning our woman, men and offspring of Mu'urish Yamaxi American Natives (Yamasee Tribe of Native Americans)-Olmec Civilization, for we are the best qualified to teach our-story, culture, art, and science, etc...

Section 2:

The Continental Mu'urish Yamaxi Empire/Mu'urish Yamaxi American Natives (Yamasee Tribe of Native Americans)-Olmec Civilization have the inalienable right to establish and control our education systems to provide education in our own language "we speak a dialect of English, Yamaxic {ᄃᄂᄃᄃᄃᄃᄃᄃᄃ}, Yamassic {ᄃᄂᄃᄃᄃᄃᄃᄃᄃ} or, Nuwaupic {ᄃᄂᄃᄃᄃᄃᄃᄃᄃ} which is Muskogean {Muskogean}" to our cultural methods of teaching and learning.

Section 3:

Measures shall be taken to ensure that the Continental Mu'urish Yamaxi Empire/Mu'urish Yamaxi American Natives-Olmec Civilization have the opportunity to acquire education at all levels (stages). In addition other governments shall recognize the inalienable right of Us the Natives/People of the Continental Mu'urish Yamaxi Empire, to establish our own educational facilities. These Governments shall recognize and respect the Imperial)-Em-Hutip University.

Section 4:

The imparting of general knowledge and skills of all Mu'urish Yamaxi American Natives-Olmec Civilization, is to participate fully and on an equal footing in their own indigenous community and in the national community shall be an aim of education for all.

Section 5:

Educational measures shall be taken among all sections of the indigenous community and in the national community, particularly among those that are in most direct contact with the Continental Mu'urish Yamaxi Empire with the object of eliminating prejudices that they may harbor in respect of our Empire. To this end, efforts shall be made to ensure that ourstory, textbooks, and other educational materials provide a fair, accurate, and informative portrayal of the societies and cultures of our Empire-Kingdom.

Imperial Law 17: Imperial Copyright, Copy Claim, Trademark and Patent

Be it enacted by Emperor-Monarch-[NR]: Sambhu Re 

Section 1:

This Statue specifically covers and protects any and all Written, Artistic and/or otherwise Creative Works. The Continental Mu'urish Yamaxi Empire reserves the inalienable right to Copyright, Copy Claim, Trademark and Patent of our own works. This especially covers all Mu'urish Yamaxi American Natives Nationality Identification, Birth Record, Right to Travel Pass, Reclamation Forms, Our Language, Etc...

Imperial Law 18:

Be it enacted by Emperor-Monarch-[NR]: Sambhu Re 🇸🇰:

Section 1:

The Mu'urish Yamaxi American Natives-Olmec Civilization will defend themselves and their Empire-Kingdom, if the need arises.

Section 2:

The Continental Mu'urish Yamaxi/Empire Mu'urish Yamaxi American Natives-Olmec Civilization will defend our homeland from foreign as well as domestic foes if the need arrives. This will be determined by the Imperial Constitutional Monarch and/or with or without the Imperial Indigenous Matriarchal Council.

Part 6

Imperial Law 19: Prevention of Desecration of Imperial Royal Flags, Imperial Flags, Imperial Royal Seals, Imperial Seals, Imperial Banners, and Treaty Flags

Be it enacted by Emperor-Monarch-[NR]: Sambhu Re 🇸🇰:

Section 1:

Legislation to Prevent Misuse, Abuse, and Desecration of the Continental Mu'urish Yamaxi Empire Imperial Royal Flags, Imperial Flags, Imperial Royal Seals, Imperial Seals, Imperial Banners, and Treaty Flags in accordance to the following Imperial Laws!

Section 2:

A Trademark cannot be registered which consists of our components amongst other things, "Imperial Royal Flag, Imperial Flags, Imperial Royal Seals, Imperial Seals, Imperial Banners, Sacred Seals, National Symbol and Treaty Flags or other insignia) of the Continental Mu'urish Yamaxi Empire, or any simulation thereof."

Section 3:

It is approved that the Imperial National Flag(s) of the Continental Mu'urish Yamaxi Empire should be raised on all holy days/holiday, festivals, classes, events, ceremonial gatherings by any group of nationals of the Empire-Kingdom.

Section 4:

These are the penalties for the Desecration, Mutilation, or Improper use of the Imperial Flag(s), within the Jurisdiction of the Continental Mu'urish Yamaxi Empire.

- a) A Fine of no less than [99 ounces of 99% per silver] for the First Offense.
- b) For the Second Offense, a national of the Continental Mu'urish Yamaxi Empire in good standing will be suspended for five (5) months. If wish to be reinstated, a national will be required to appear before the Imperial Indigenous Matriarchal Council.
- c) On the Third and Final Offense, the national will be suspected of Treason, you have thus forfeited the privilege of being a national of the Continental Mu'urish Yamaxi Empire and the national will be dismissed, henceforth, all Legal documents pertaining to the Continental Mu'urish Yamaxi Empire are Null and Void, instantaneously.

Section 5:

The placing of any Word, Figure, Mark, Picture, Design, Drawing or Advertisement of whatever Nature upon any Continental Mu'urish Yamaxi Empire Imperial Royal Flag or Imperial National Flag(s) or any Picture or Representation on any Continental Mu'urish Yamaxi Empire Imperial Royal Flag or Imperial National Flag(s) is Prohibited and Punishable by the above and below stated Imperial Laws.

Section 6:

The Mutilation, Defacement, Defiance, Abuse, or Improper use of the Continental Mu'urish Yamaxi Empire Imperial Royal Flag or Imperial National Flag(s) including but not limited to the use of the Imperial Royal Flag or Imperial National Flag(s) for making clothes and/or to wrap merchandise in, is Prohibited and is also Punishable by Imperial Law. The Possession, Sale, or Public Display of any article of merchandise bearing the [Imperial Royal Flags, Imperial Flags, Imperial Royal Seals, Imperial Seals, Imperial Banners, Sacred Seals, National Symbol, or other Insignia] of the Continental Mu'urish Yamaxi Empire, without written permission from the Imperial Executive House is Prohibited.

Prohibition of Abuse of Foreign Flags

Section 7:

The Abuse, Misuse, and Desecration of any Foreign Flag are prohibited in the Continental Mu'urish Yamaxi Empire.

Section 8:

In the event that a national fails to comply with this Imperial Law the national must appear before the Imperial Indigenous Matriarchal Council.

Section 9:

The Imperial Flag Laws do not prohibit the use of the Flag on Stationary, in Books or other Printed Matter, Provided:

- a) There are no Words or Designs of any kind on the Imperial Royal Flag or Imperial National Flag(s),
- b) Its use is not connected in any way with Advertising, and
- c) You must receive permission from the Imperial Indigenous Matriarchal Council.

Section 10:

The Pledge of the Imperial Royal Flag of the Continental Mu'urish Yamaxi Empire:
