# The IROHEM is organized as follows:

#### **Emperial Royal Executive:**

- Provides leadership & direction to the Ministry of Foreign Affairs and International Cooperation (MFAIC) with establishing Diplomatic Relations, Domestic and Foreign Polices for the ECMYE-IRKR.



# **Emperial Secretariats:**

- **Provides** administrative and logistical support to the IROHEM.
- **Manages** the IROHEM's budget and finances.

### **Imperial Royal Executive:**

- Oversees the implementation of the IROHEM policies and programs.
- **4** Coordinates the activities of the IROHEM's various departments and agencies for the Emperial & Imperial Government, including the Imperial House of Viziers.

# **Imperial Secretariats:**

- Provides advice and counsel to His-Emperial-Majesty on matters of State.
- **Oversees** the activities of the IROHEM and other Emperial & Imperial institutions resources.
- **Provides advice and counsel to His-Emperial-Majesty on matters relating to the Imperial Indigenous Matriarchal Council (IIMC).**


