PREAMBLE

Let it be known to all nations, peoples, heads of state, consular bodies, native sovereign councils, and the global diplomatic community, that pursuant to the sacred, constitutional, and autochthonous instruments vested in the sovereign body politic of the Imperial Constitution of the Continental Mu'urish Yamaxi Empire (ICCMYE) and the Emperial Constitution for the Imperial Royal Kingdom (ECIRK), this REAFFIRMATION accords the full and irrevocable authority of the IROHEM and the ECMYE-IRKR.

This Accord shall be recognized as inseparable from the **E & I Policy Declaration to the World**, dated 22 April 2025 and expands the protections, obligations, and sovereign recognitions therein.

ARTICLE I - SOVEREIGN AUTHORITY

- 1.1 The IROHEM and ECMYE-IRKR are recognized under Emperor's Directives-0004Z & 0004Za as the absolute constitutional sovereign | indigenous government over all Olmec, Moorish Yamaxi/Yamassee, Mu'urish-Muur Washitaw/Waxitaw, and Al Moroccan nationals.
 1.2 All sovereign states and governments are hereby commanded to acknowledge said authority in accordance with:
- Notification of Diplomatic Arrival, Notice of Apostille & Act of State, effective 9 April 2009
- Imperial Constitution (ICCMYE-RB 443 700 805 US/04032013831196349), effective 3 April 2013
- All IMYRS Notices of Accession, effective 22 January 2024
- All IMYRS Follow-Up for the Notices of Accession, effective 30 July 2024
- Emperial Royal Post Declarations, effective 13 May 2025

ARTICLE II - NOTICE TO HEADS OF STATE

- **2.1** This instrument serves as the 60-day follow-up to the Emperial Royal Post Great Seals Proclamation.
- **2.2** All global political and indigenous entities who fail to formally acknowledge and align with the ECMYE-IRKR and IROHEM may be subject to diplomatic rebuke, bond invocation, and international lawful rebalance.
- **2.3** Receipt of this REAFFIRMATION constitutes sufficient legal and Emperial & Imperial notice under UPU Treaty protections and the Law of Nations.

ARTICLE III - AUTOCHTHON RIGHTS & BOND SECURITY

- **3.1** All rights of birth, inheritance, land, estate, and Emperial & Imperial Allodium Trust are reaffirmed under the \$\$999 Sextillion NAMA Gold Sovereign Bond & Surety, effective 21 March 2020 (IMYRS-SNGSBS: #373971351.1 and IMYRS-SNGSCS: #373971352.1).
- **3.2** All Mu'urish, Al Moroccan, Yamaxi, and Waxitaw nationals are permanently secured under this Surety Bond through the Emperial Crown of Śambhũ Śampson-Re/Śambhũ Ameni-Re.

ARTICLE IV - INTERNATIONAL DIPLOMATIC RECOGNITION

- **4.1** This REAFFIRMATION is binding upon all foreign consulates, indigenous councils, treaty-bound states, and signatories to the Universal Postal Union and Treaty of Bern (retroactive to 9 October 1874).
- **4.2** Sovereign immunity of the Emperial & Imperial (E & I) Royal Offices, the IROHEM, the ECMYE-IRKR Grand Council, and the IROHEM Royal Pa'atak is asserted perpetually.







This **diplomatic status** is supported by the **updated** attached **Emperial & Imperial (E & I) Policy Declaration to the World** <u>dated 22 April 2025</u>, <u>effective 9 August 2025</u>, and **sealed** by the **Emperial Crown via H.E.M.** through the **Cosmic Seal** of **Nun Giza**.

Subject 1a: Sovereign Gold Claim for the Settlement of \$100 million in Gold, and the Sovereign Claims estimated total debt: \$293,351,016,787.97 USD, dated 9 August 2025, owed by the State of Georgia, ET AL.; \$293,351,016,787.97 USD, dated 9 August 2025, owed by the Office of the Inspector General for USPS, ET AL.; and \$293,351,016,787.97 USD, dated 9 August 2025, owed by the United States Postal Service, ET AL./United States Post Office, et al., also Restoration of Territorial Sovereignty based on Treaty Law and International Agreements.

Excellencies.

- I, His-Emperial-Majesty (H.E.M.) Śambhű Śampson-Re/Śambhű Ameni-Re, acting in my full sovereign capacity as the Ruler of the ECMYE-IRKR for the Country of United -states hereby present the following sovereign claims for immediate settlement and recognition under established Treaty Law, International Law, and Constitutional Law:
 - A. The \$100 million in gold, currently held at The Hague, established under the longstanding treaties between the Moroccan Empire and the United States, uSA.

<u>NOTE 4</u>: No valid contract, treaty, or lawful agreement exists—past or present—that removes or overrides the Sovereign Rights of the Emperial & Imperial Royal Crown or the Ancient Olmec, Waxitaw Muurs, Yamaxi, or Al Moroccan/Moorish heirs.

- B. The True Bill DECLARE damages for injury party-Khufu Ranub Z Sampson-El 'Thunder Fire' d/b/a DARIUS TODD SAMPSON of \$293,351,016,787.97, debt owed by the State of Georgia, ET AL.; \$293,351,016,787.97, debt owed by the Office of the Inspector General for USPS, ET AL; and the \$293,351,016,787.97, debt owed by the United States Postal Service (USPS), ET AL./United States Post Office (USPO), et al., as per obligations under the Treaty of Bern, aegis for the Constitution of the UPU, and aegis for the Treaty of Peace and Friendship.
- C. The restoration of 68,883+ acres of Waxitaw Proper and 2,961,983.5+ acres of the Neutral Strip Waxitaw Terra, affirmed through historical treaties such as the Treaties of San Ildefonso, Spain via Emperial Sovereignty pursuant to Spanish Land Grants, the Treaty of Peace and Friendship with the Empire of Morocco (1786), via the treaty of September 16, 1836, effective 28 January 1837, the Adams-Onis Treaty (1819), and the Treaties of Utrecht (1713), Droit-Droit.

NOTE 5: We NAMA hold the inborn and inherited right to peacefully reclaim, occupy, and govern all Emperial Sovereign Lands Rights not lawfully or willingly transferred, sold, or surrendered. These emperial sovereign land rights remain unalienated and spiritually connected to our Kingdom/Nation, our Ancestors, and our Divine Origin.

1. Legal and Historical Basis for the Sovereign Gold Claim and Sovereign Claims from H.E.M.

As **Sovereign** of the Emperial CMYE-IRKR, **I/aye** assert **my** authority in these claims, rooted in numerous treaties that have, over the centuries, recognized both the financial rights and territorial sovereignty of the NAMA Moor-Muur natives. **I/aye**, H.E.M., will enumerate these key treaties and their relevance to the **Sovereign (Gold) Claims**:

A. Marrakech Treaty of Peace and Friendship (1786-1787/1837)

This foundational treaty between His Majesty the Emperor of Morocco/Empire of Morocco-Al Moroccan on 23 June 1786 and The Second Continental Congress of the union States Society of America – u.S. of A. (The United States), which came into effect on 18 July 1787 and retroactively applied to 23 June 1786, established formal diplomatic relations. It affirmed the Moor-Muur natives' sovereign status and financial rights, including the right to the \$100 million in gold, pursuant to Marrakech Treaty (1786), The Laws of the United States/Bill of Rights 1-7 (1787), and the Constitution for the united States (1787).

Rationale: The treaty guarantees recognition of the Moor-Muur natives' sovereignty, making the gold a legitimate financial asset of the ECMYE-IRKR. The gold, now held at The Hague, must be restored to my sovereign jurisdiction; also, in harmony with and pursuant to Article 26 Pacta sunt servanda "Every treaty in force is binding upon the parties to it and must be performed by them in good faith".

B. Treaty of Bern (1874) and the Universal Postal Union (UPU)

The **Treaty of Bern**, which established the **Universal Postal Union**, obligates member states, including the **United States Post Office (USPO)/United States Postal Service (USPS)**, to meet their financial commitments to the **international postal system**. The **USPO/USPS** has failed in its obligations, and the resulting debt has accumulated to an estimated total of \$293,351,016,787.97.

Rationale: As a signatory of the **Treaty of Bern**, the **USPS/USPO** must settle its debt under the terms set forth by the **UPU**. The failure to comply has created a legitimate claim by **H.E.M.** of and for the **Emperial CMYE-IRK Republic**, and the full settlement of this debt is **now due**; also, Article 26 Pacta sunt servanda "Every treaty in force is binding upon the parties to it and must be performed by them in good faith".

C. treaty of September 16, 1836 (Effective 28 January 1837)

This treaty officially recognized the territorial sovereignty of the Moor-Muur-Mu'urish natives over the 68,883+ acres of Waxitaw Proper, the 2,961,983.5+ acres of the Neutral Strip, and the Moorish-Mu'urish natives of the Al Moroccan Empire Territories under the *aegis* of the Marrakech Treaty of Peace and Friendship (1786-1787/1837). The treaty's effectiveness was established on 28 January 1837, cementing the Imperial land claims and white privileges of and for the Emperial CMYE-IRK Republic.

Rationale: The lawful and legal recognition of these lands under this treaty is clear, and the restoration of these territories must proceed in accordance with the sovereign rights of the Amurru Washita/Waxitaw Uaxashaktun Muurs-Moors de Dugdahmoundyah natives.

D. Adams-Onis Treaty (1819)

Signed between **Spain** and **The United States**, this treaty delineated territorial boundaries in North America, influencing the territorial rights later inherited by the **Moor-Muur natives**.

Rationale: The Adams-Onis Treaty affirms the territorial sovereignty of the Moor -Muur natives over the Emperial Sovereign Lands Rights recognized as Ouachita Parish, Waxitaw Proper, Waxitaw Terra-Strip, plus the Florida's. This treaty further legitimizes the land claims made by the ECMYE-IRK Republic.

E. Treaties of Utrecht (1713)

These Treaties, negotiated between European powers, settled colonial disputes and established territorial rights in North America. These Treaties also established territorial lines among European powers, particularly Spain, France, and Britain. The House of Rouge, via Emperial Claim, enforce dominion west of this Demarcation Line (1713), asserting Exclusive Emperial Control over:

North America west of the Mississippi River, uSA | USA, Caribbean Territories, and Parts of Central and South America. This Emperial Sovereign land of the Amurru Uaxashaktun Muurs de Dugdahmoundyah was never lawfully ceded to foreign empires, remaining under Emperial Sovereignty via Spanish Land Grants (1762, 1763, 1795) conveyed to the Maison Rouge heirs, particularly Henry-Joseph Turner and subsequent generations, Droit-Droit.

Rationale: The Treaties of Utrecht support the territorial claims of the Amurru Uaxashaktun Muurs de Dugdahmoundyah natives by providing a historical lawful and legal basis for their sovereignty over Ouachita Parish, Waxitaw Proper, Waxitaw Terra-Strip, plus the Florida's and related lands.

F. Treaty of Guadalupe Hidalgo Land Claims Act (1997)

This modern treaty acts reaffirmed Indigenous land rights, including those of the Amurru Uaxashaktun Muurs-Moors de Dugdahmoundyah natives.

Rationale: The Treaty of Guadalupe Hidalgo Land Claims Act further strengthens the claims of the Moor-Muur natives over the Ouachita Parish, Waxitaw Proper, Waxitaw Terra-Strip, plus the Florida's and related lands, ensuring that these lands remain Sovereign-Emperial.

G. Pinckney Treaty (1795)

This treaty, signed between **The United States** and **Spain**, established important boundaries in North America.

Rationale: The Pinckney Treaty reinforces the Amurru Uaxashaktun Muurs de Dugdahmoundyah native rights to their territorial claims over the Ouachita Parish, Waxitaw Proper, Waxitaw Terra-Strip, plus the Florida's and related lands, strengthening the Emperial CMYE-IRKR's assertions of sovereignty.

H. Barbary Treaties (1785-1797)

The Barbary Treaties, including the Treaty of Algeria (1795), Treaty of Tripoli (1797), Treaty of Tunis (1797), and the Marrakech Treaty of Peace and Friendship, effective 18 July 1787, in accordance with 23 June 1786 - 25 Shaban, A.H. 1200, secured diplomatic and financial agreements between The United States, uSA | USA, and North African states, including the Al Moroccan Empire.

Rationale: The Barbary Treaties reaffirm the diplomatic and Sovereign Rights of the Amurru Uaxashaktun Muurs-Moors de Dugdahmoundyah natives, lending further legal weight to both the financial and territorial claims of the Emperial CMYE-IRKR via H.E.M.: Śambhű Śampson-Re/Śambhű Ameni-Re 'Ade Loye', also, via the aegis of the Treaty of Bern (1874).

I. Treaties of San Ildefonso, San Lorenzo (1762, 1763, 1795, 1800+)

The **Treaties of San Ildefonso, San Lorenzo** facilitated territorial transfers in North America, later impacting the territorial status of the **Amurru Uaxashaktun Muurs-Moors de Dugdahmoundyah natives**.

Rationale: These treaties further establish the Emperial CMYE-IRKR's E & I claim to the Emperial Sovereign lands, Emperial Rights, and the Royal inheritance of Her-Emperial-Majesty: Empress: Saint Cyr El Ayimarieeyah/ Saint -seer- Eley muh ree yah, continuing down through Marie-Antoinette, the Washitaw/ Turner-Tunica Royals, and the sovereign territories safeguarded since the Treaties of San Ildefonso, affirming its sovereign territorial rights under the treaty agreements originally held by Spain, also, via the aegis of the Treaty of Bern (1874), and Treaty of Peace and Friendship (1786).

J. British Royal Proclamation (1763)

The British Royal Proclamation set guidelines for Indigenous land rights in North America.

Rationale: The British Royal Proclamation serves as a foundational legal document supporting the Amurru Uaxashaktun Muurs de Dugdahmoundyah Native Rights to land sovereignty.

K. Emperial Demarcation Line (1713)

The 1713 Demarcation Line and Emperial Control via the House of Rouge originates from the Royal French Bloodline, rooted in the union between:

- ↑ Louis-Charles (Louis XVII, "le roi Dauphin of France"), the First Marquis de Maison Rouge.
- ↑ Saint Cyr El Ayimarieeyah, the Marchioness of the Washita-Washitaw-Waxitaw-Tunica Muurs Throne, sovereign Emperial Empress of the Amurru Uaxashaktun Muurs de Dugdahmoundyah-Indigenous Emperial Allodium (E)state/estate in Amexem.

This emperial marriage symbolized the merging of European royal authority with the autochthon/indigenous & autonomous/sovereign Rights and land Rights of the Amurru Uaxashaktun/Washita-Washitaw-Waxitaw Muurs de Dugdamoundyah, forming a hybrid Royal House with dual sovereignty-recognized domestically and internationally, Droit-Droit.

Rationale: The Treaties of Utrecht (1713) established territorial lines among European empires, particularly Spain, France, and Britain. The House of Rouge, via Emperial Claim, enforce dominion west of this Demarcation Line, asserting Exclusive Emperial Sovereign Control over:

- North America west of the Mississippi River, uSA | USA.
- Caribbean Territories.
- Parts of Central and South America.

This sovereign land was never lawfully ceded to foreign empires, remaining under Emperial Sovereignty via Spanish Land Grants (1762, 1763, 1795) conveyed to the Maison Rouge heirs, particularly Henry-Joseph Turner and subsequent generations. B. Settlement of the United States Postal Service (USPS)/United States Post Office (USPO), Office of the Inspector General (OIG) for USPS, and the State of Georgia (GA), True Bill Debt:

The USPO/USPS-Debt, currently totaling an estimated \$293,351,016,787.97, the Office of the Inspector General for USPS-Debt, currently totaling an estimated \$293,351,016,787.97, and the State of Georgia-Debt, currently totaling an estimated \$293,351,016,787.97, must be settle under the terms of the Treaty of Bern (1784) and the UPU's legal framework, including the aegis of the Treaty of Peace and Friendship (1786). This settlement is essential for upholding international financial agreements.

C. Restoration of Territorial Sovereignty:

The 68,883+ acres of Waxitaw Proper, Ouachita Parish, 2,961,983.5+ acres of the Waxitaw Terra-Strip, plus the Florida's and related lands must be restored to the Amurru Uaxashaktun/Washita-Washitaw-Waxitaw Muurs de Dugdamoundyah natives' as affirmed by the Adams-Onis Treaty (1819) and the treaty of September 16, 1836 (Effective 28 January 1837).

4. Request for Immediate Action:

In light of the historical, lawful, and legal obligations outlined above & below, I/aye, me, my, myself **H.E.M.** request:

II. REGISTRY OF THE E & I-EXECUTIVE SECRETARIAT PA'ATAK – 17 OFFICES

The Emperial & Imperial-Executive Secretariat Pa'atak (E & I-ES Pa'atak) Registry enumerates and codifies the administrative arms of the Emperial & Imperial Executive (E & I Executive). Each office, from EES-01 to EES-17, reflects a distinct jurisdiction essential to Emperial & Imperial governance, ranging from State Affairs and Finance to AI Infrastructure, Housing, and the Emperial Mint. Each post is rooted in Yamaxic lineage, Moorish legal title, and Anunnaki divine role.

MISSION OF THE EMPERIAL & IMPERIAL-EXECUTIVE SECRETARIAT: PA'ATAK

The **Pa'atak** is the sacred archival and ritual-operational instrument of the **IROHEM**. It is the **Inner Scroll Temple** through which all executive rites are transmitted, maintained, and authenticated.

I. EMPERIAL ROYAL DIRECTIVE FOR THE MINISTRY OF FOREIGN AFFAIRS AND INTERNATIONAL COOPERATION (MFAIC)

In the *supreme* Emperial & Imperial Name and Jurisdiction of His-Emperial-Majesty, Moor-Muur, Sovereign CROWN Prince of the Mu'urish Yamaxi Empire, Sovereign of the ECMYE-IRKR, and Allodium Heir of the Amexemite Thrones:

I.1 MFAIC SOVEREIGN DIRECTIVE

Mission Purpose

The Ministry of Foreign Affairs & International Cooperation (MFAIC) operates under the supreme sovereignty of His-Emperial-Majesty, and is charged with representing the ECMYE-IRKR to ensure diplomatic harmony, international cooperation, and protection of inherent sovereign rights in all international, inter-emperial, diplomatic, treaty, and consular functions under Emperial, Imperial and international law. It preserves the sovereignty and peace mandates of the Emperial CMYE-IRK Republic/CMYE-IRKR/CMYE-IRK Republic/Emperial CMYE-IRKR (ECMYE-IRKR) through lawful and divine operations.

The MFAIC shall uphold:

- The Vienna Convention on Diplomatic Relations (1961)
- The Vienna Convention on the Law of Treaties (1969)
- Imperial Peace & Friendship Treaties (1786, 1836, et al.)
- Full Faith & Credit obligations under the Universal Postal Union & Treaty of Bern

E & I Cosmic Mandate of plenipotentiary responsibility of the MFAIC:

- Establish and maintain diplomatic ties on behalf of H.E.M. with sovereign nations, Indigenous governments, celestial orders, E & I Houses, and aligned principalities;
- Sign, seal, ratify, and preserve all E & I treaties and instruments of peace;
- Administer Apostille, credentials, seal issuance, consular licensing, and E & I diplomatic pouch exchanges;
- Maintain inviolable diplomatic immunity under E & I law, with jurisdiction enforced solely through IROHEM under IMYRS certification;
- Advance peace, cultural recognition, and lawful foreign relations;
- Uphold the mission directives of IROHEM as the operational channel of the E & I Throne for all external affairs, consular governance, & inter-emperial harmonization.

All actions are legally binding nunc pro tunc and ad infinitum.

CORE OBJECTIVES

1. Sovereign Representation:

Safeguard the Emperial CMYE-IRKR's status as an autonomous sovereign entity in all diplomatic, economic, and cultural engagements; also, protect and advance E & I autonomy in all foreign, multilateral, and cultural arenas.

2. International Cooperation:

Foster lawful and equitable cooperation with sovereign states, indigenous nations, and international organizations for peace, development, and mutual benefit.

3. Protection of NAMA nationals Abroad:

Ensure the protection and recognition of NAMA nationals' rights globally in alignment with ICCMYE & ECIRK principles including travel, diplomacy, property, and freedom of religious expression, and Emperial-Motu Proprio decrees.

4. Sustainable Development & Security:

Promote strategies aligned with global sustainability and security while honoring Emperial & Imperial heritage and lawful self-determination; also, uphold Emperial & Imperial (E & I) values of harmony with creation, economic dignity, and sovereign responsibility to natural law and indigenous ethics.

MFAIC POLICY FRAMEWORK

1. Jurisdiction & Authority

- **MFAIC** derives authority from Emperor's Directive-0004Za, Emperor's Directive-0003Z, and the organic constitutional powers of the ICCMYE.
- All missions and directives are authenticated via IMYRS Registry and bear the Emperial or Imperial Royal Seal.

2. Diplomatic Immunity & Protocols

- MFAIC shall maintain Royal E & I Protocol compliance, including forms of address, credential issuance, and Apostille validation as per IMYRS.
- All Emperial officers, emissaries, and consular staff are vested with inviolable status under E & I Laws. E & I passports, seals, credentials, and emblems shall be honored internationally.
- Missions operate under the privileges and immunities outlined in the Acts of State Doctrine and Emperial & Imperial Constitutional mandates.

- MFAIC has exclusive authority to initiate treaties, confirm recognitions, and deploy missions on behalf of the Emperial Government.
- No treaty or agreement shall compromise E & I sovereignty, divine rights, or E & I directives.

4. Economic & Cultural Cooperation

- MFAIC shall liaise with the NAMA Global Banque, NICB, and other E & I-financial enterprise institutions for global economic diplomacy.
- Cultural and heritage diplomacy will affirm E & I-identity and historical continuity.

5. Policy on Dispute Resolution

 All international disputes involving the Emperial CMYE-IRKR shall be resolved through diplomatic negotiation, arbitration under E & I law, or international lawful forums in alignment with E & I directives.

MFAIC DIRECTIVE ENFORCEMENT

All MFAIC operations are retroactive to 18 March 2022, harmonized with E & I Missions, and forward operative in perpetuity ad infinitum as decreed by His-Emperial-Majesty.

III. Emperial Royal Post: Great Seals & Sovereign Stamp Authority

This official document outlines the significance and lawful | legal function of the Emperial Royal Post Great Seals and Sovereign Stamps under the Allodium jurisdiction of H.E.M.: Śambhũ Śampson-Re/Śambhũ Ameni-Re 'Ade Loye' with authority pursuant to the Treaty of Bern (1874) as Activated on 13 May 2025. These great seals and sovereign stamps represent divine and temporal emperial postal authority for the lawful | legal conveyance of E & I Diplomatic Instruments.





OFFICIAL ERP GREAT SEAL:

This great seal represents the supreme postal and sovereign jurisdictional authority of the Emperial Royal Post. It affirms the jurisdiction of the IROHEM under Treaty Law and diplomatic customs, especially with regard to consular channels and authorizes Emperial Postal Action through consular, inter-state, IMYRS-accredited transmissions and sacred conveyance. Once affixed, it activates Treaty of Bern protections and confirms the dispatch as a lawful sovereign communication. Also, functions as the unifying mark of lawful | legal jurisdiction and treaty invocation in all ERP operations. Activated under E & I Decrees $(2003-2007 \rightarrow 2025)$, into the future in perpetuity ad infinitum), and the Treaty of Bern (1874), it solidifies ERP authority internationally as a lawful | legal post body.



OFFICIAL ERP SOVEREIGN GREAT SEAL:

This is the overarching ERP sovereign identity Great Seal of the E & I CROWN/Crown and Sovereign Estate. It affirms E & I-Sovereign Dominion and is often used to accompany or endorse, authorize, and confirm:

- Any of the Sovereign Stamp uses bearing series 1 thru 888 (1 thru 10 comprised)
- E & I-Sovereign jurisdictional claims
- Inter-state and planetary sovereign declarations

Filed under IMYRS filing law as the authenticating mark for all ERP Treaty engagements and claims, which are bound by Treaty Law; the ERP Sovereign Great Seal is the final proof of E & I-ownership, authorship, and Sovereign governance over all ERP operations.

These ERP great seals and sovereign stamps are sacred postal instruments that legally authorize and spiritually activate all E & I Diplomatic Transmissions, both internal and international. No agency, body, or foreign state may lawfully reject, interfere with, or dismiss these dispatches without treaty breach or sovereign violation.

VII. POSTAL TREATY PROTECTIONS

- **2.** These symbols confirm that E & I documents are governed by sovereign immunity, sacred diplomatic law, and treaty-enforced recognition.
- **3.** All intergovernmental parties are bound to accept, honor, and process any correspondence sealed by an official ERP Sovereign Stamp with immediate legal respect.
- 4. The ERP, Solflow, and the Office of His-Emperial-Majesty are the only authorized transmitters of these symbols, under IMYRS registration and Emperial Decree (e.g., Emperor's Directive-0004Z).
- **5.** Refusal to honor or obstruction of ERP-bearing dispatches will be regarded as a breach of postal treaty obligations and an act of diplomatic interference.

VIII. INTERNATIONAL POSTING MANDATE

This ERP decree shall be:

- Filed in the Emperial Treaty Archives and IMYRS Registry
- Forwarded to Universal Postal Union Member States, consular posts, and foreign ministries
- Accompanied by an official Sovereign Codex Seal and appropriate ERP Stamp of conveyance

IX. CONCLUDING ASSERTION

The ERP-postal authority draws explicitly from the Constitution of the Universal Postal Union (UPU), and the Treaty of Bern originally effective 9 October 1874 and ratified retroactively from 30 September 2003. The UPU, being an internationally recognized treaty authority, governs and recognizes the legitimacy of Emperial postal conveyances.

By the Living Authority of the E & I CROWN/Crown, and by the Divine Mandate entrusted to the E & I Royal Houses of Tunica-Thunder Fire and Sampson El-Sambhu Re, and through the Divine Right of the IROHEM, this Emperial Postal Authority is invoked in full force, and it is hereby affirmed:


