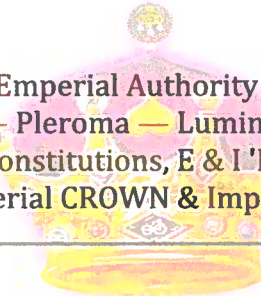

This EMOU, ECFRRA & EDOFA are issued under the supreme E & I Sovereign Authority of:

- **Emperor's Directive-0004Za:** Emperial Constitution for the Imperial Royal Kingdom (ECIRK)~via~**Emperor's Directive-0004Z:** Imperial Constitution of the Continental Mu'urish Yamaxi Empire (ICCMYE-2013), and Emperial Royal Post Constitution (ERPC-2025), and all Effective Dates from 2003→2026, is asserted perpetually.
- **Emperor's Directive-0003Z:** Notice of Diplomatic Arrival, Apostille, and Official-Act of State—effective 9 April 2009.
- **Royal Emperial-Motu Proprio to the World:** Filed 9 August 2025, effective globally under Emperial & Imperial Royal Decree and Treaty Rights.
- **IMYRS Reference:** EFN-IMYRS-AL/2025-IGDD-0001, effective 15 November 2025.

In light of the Unified Imperial Diplomatic Notice & Imperial Guardian Directive—effective 15 November 2025, the **Royal** Imperial-Motu Proprio to the World—effective 9 August 2025, including all associated Notices of Accession and Imperial Royal Post dispatches, the parties affirm their willingness to cooperate in good faith and mutual honor. This document reflects a shared intention to engage constructively, in alignment with the **E & I diplomatic point of presence**, E & I Protocols, and all applicable sovereign instruments, **Shalama**.

I. DEFINITIONS & INTERPRETATION

For the purposes of this **EMOU**, the following terms shall apply:

- **"Sovereign"**: H.E.M.: Emperor: Šambhū-Eleleth Šampson-**Re** 'Ade Loye', heirs, and all duly appointed Imperial & Imperial representatives.
- **"IMYRS"**: Imperial Muurish Yamaxi Recording Service, the E & I sovereign archive of all Imperial, Imperial, diplomatic, and ceremonial performances.
- **"ERP"**: Imperial Royal Post, the sovereign postal and communication service of the ECMYE-IRKR.
- **"Estate Property"**: Any land, building, archive, or facility held, recognized, or assigned under Imperial & Imperial rights or this EMOU.
- **"Consular Authority"**: The sovereign right to maintain and operate consular functions, missions, and personnel under Imperial, Imperial, International, and Treaty Law.
- **"EMOU"**: This Imperial Memorandum of Understanding, including all appendices.

II. TITLE & PARTIES

This **EMOU** is entered into between ECMYE-IRK Republic:

- Office of the Governor, State of Georgia (*Minor*), USA
- Secretary of State, State of Georgia (*Minor*), USA
- Office of the Governor, State of North Carolina (*Minor*), USA
- Office of the Governor, State of Alabama (*Minor*), USA
- Office of the Governor, State of Louisiana State (*Minor*), USA
- United Mexico States, Ministry of Foreign Affairs, Washington, D.C., USA
- Kingdom of Morocco, Ministry of Foreign Affairs, Washington, D.C., USA
- US Department of State, Office of Secretary of State, Washington, D.C., USA
- United States Postal Service (USPS) District Manager – Georgia Region
- The Director, UPU International Bureau, Bern, Switzerland
- Grand Army of the Republic (GAR), Arlington, Virginia, USA

III. SOVEREIGN PREAMBLE & AUTHORITY

WHEREAS, it is the supreme and immutable right of His-Imperial-Majesty to establish, affirm, and maintain E & I jurisdiction and lawful diplomatic relations, pursuant to Imperial, Imperial, Indigenous Rights, International, and Treaty Law, including but not limited to the Treaty of Bern (1874), Vienna Convention (1961), Marrakech Treaty of Peace and Friendship (1837/1786), Treaties of Utrecht (1713), UNDRIP, all Imperial & Imperial 'Royal' Motu Propria's, and Imperial & Imperial Constitutions.

IV. PURPOSE & SCOPE

To formalize estate coordination, administrative peace, consular liaison, ERP presence, and mutual respect under Treaty Law, **E & I** sovereign authority, NAMA-full faith and sovereign gold-credit guarantee, all under H.E.M., GA, VA, MD, DE, NJ, PA & US-full faith and credit, & all Effective Dates from 2003→2026, is asserted perpetually, and international law, with explicit affirmation and protection of Imperial, Imperial and Indigenous Rights.

This EMOU affirms Imperial & Imperial diplomatic engagement, ceremonial presence, estate rights, and consular offices in Georgia, other union -states of America, uSA | USA, and all recognized domains, including notification to Morocco, United Mexico States, GAR and the UPU.

V. ROLES, RESPONSIBILITIES & OBLIGATIONS

Imperial CMYE-IRK Republic:

- Establish **E & I** Missions via IROHEM, consular services, and cultural liaison offices.
- Deploy diplomatic personnel and maintain **E & I** Land Claims via IMYRS.
- Provide ceremonial, educational, and documentation support.
- Maintain sovereign immunity and record all performances through the IMYRS.

State of Georgia | other union -states of America, uSA | USA/ Parties:

- Acknowledge **E & I** filings via IROHEM and diplomatic status.
- Ensure non-obstruction of **E & I** operations via IROHEM.
- Provide safe passage and refrain from interference.

Mutual Obligations:

- Uphold peaceful relations and lawful cooperation.
- Communicate and resolve any disputes by diplomatic channels.
- Recognize Imperial & Imperial documents, ERP pouches, and IMYRS records.

VI. AFFIRMATION OF UNDRIP & INDIGENOUS RIGHTS

All Parties affirm commitment to the cultural, spiritual, territorial, and political rights of NAMA nationals as Indigenous Peoples, via this EMOU, and shall be interpreted, applied, & enforced in accordance with the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP), and adopted per Emperor's Directive-0004Za: Imperial Constitution for the Imperial Royal Kingdom (ECIRK)-via-Emperor's Directive-0004Z: Imperial Constitution of the Continental Mu'urish Yamaxi Empire (ICCMYE-2013), and all Effective Dates from 2003→2026, is asserted perpetually, including but not limited to:

- **Article 3:** Right to self-determination, economic, social, and cultural development.

Article 3 – Original

Indigenous peoples "NAMA nationals-American State Citizens" have the right to self-determination. By virtue of that right they freely determine their political status and freely pursue their economic, social and cultural development.

- **Articles 4 & 5:** Right to autonomy, self-government, and distinct institutions.

Article 4 – Original

Indigenous peoples "NAMA nationals-American State Citizens", in exercising their right to self-determination, have the right to autonomy or self-government in matters relating to their internal and local affairs, as well as ways and means for financing their autonomous functions.

Article 5 – Original

Indigenous peoples "NAMA nationals-American State Citizens" have the right to maintain and strengthen their distinct political, legal, economic, social and cultural institutions, while retaining their right to participate fully, if they so choose, in the political, economic, social and cultural life of the State.

- **Article 8:** Protection against forced assimilation or destruction of culture.

Article 8 – Original

1. Indigenous peoples "NAMA nationals-American State Citizens" and individuals have the right not to be subjected to forced assimilation or destruction of their culture.

2. States shall provide effective mechanisms for prevention of, and redress for:

(a) Any action which has the aim or effect of depriving them of their integrity as distinct peoples, or of their cultural values or ethnic identities;

(b) Any action which has the aim or effect of dispossessing them of their lands, territories or resources;

(c) Any form of forced population transfer which has the aim or effect of violating or undermining any of their rights;

(d) Any form of forced assimilation or integration;

(e) Any form of propaganda designed to promote or incite racial or ethnic discrimination directed against them.

- **Articles 18—20:** Right to decision-making and free, prior, and informed consent.

Article 18 – Original

Indigenous peoples "NAMA nationals-American State Citizens" have the right to participate in decision-making in matters which would affect their rights, through representatives chosen by themselves in accordance with their own procedures, as well as to maintain and develop their own indigenous decision-making institutions.

Article 19 – Original

States shall consult and cooperate in good faith with the indigenous peoples "NAMA nationals-American State Citizens" concerned through their own representative institutions in order to obtain their free, prior and informed consent before adopting and implementing legislative or administrative measures that may affect them.

Article 20 – Original

1. Indigenous peoples "NAMA nationals-American State Citizens" have the right to maintain and develop their political, economic and social systems or institutions, to be secure in the enjoyment of their own means of subsistence and development, and to engage freely in all their traditional and other economic activities.

2. Indigenous peoples "NAMA nationals-American State Citizens" deprived of their means of subsistence and development are entitled to just and fair redress.

- **Articles 26—28:** Rights to lands, territories, resources, and redress.

Article 26 – Original

1. Indigenous peoples "NAMA nationals-American State Citizens" have the right to the lands, territories and resources which they have traditionally owned, occupied or otherwise used or acquired.

2. Indigenous peoples "NAMA nationals-American State Citizens" have the right to own, use, develop and control the lands, territories and resources that they possess by reason of traditional ownership or other traditional occupation or use, as well as those which they have otherwise acquired.

3. States shall give legal recognition and protection to these lands, territories and resources. Such recognition shall be conducted with due respect to the customs, traditions and land tenure systems of the indigenous peoples concerned.

Article 27 – Original

States shall establish and implement, in conjunction with indigenous peoples concerned, a fair, independent, impartial, open and transparent process, giving due recognition to indigenous peoples' laws, traditions, customs and land tenure systems, to recognize and adjudicate the rights of indigenous peoples pertaining to their lands, territories and resources, including those which were traditionally owned or otherwise occupied or used. Indigenous peoples "NAMA nationals-American State Citizens" shall have the right to participate in this process.

Article 28 – Original

1. Indigenous peoples "NAMA nationals-American State Citizens" have the right to redress, by means that can include restitution or, when this is not possible, just, fair and equitable compensation, for the lands, territories and resources which they have traditionally owned or otherwise occupied or used, and which have been confiscated, taken, occupied, used or damaged without their free, prior and informed consent.

2. Unless otherwise freely agreed upon by the peoples concerned, compensation shall take the form of lands, territories and resources equal in quality, size and legal status or of monetary compensation or other appropriate redress.

- **Articles 31:** Rights to protect and develop cultural heritage, knowledge, and sacred customs.

Article 31 – Original

1. Indigenous peoples "NAMA nationals-American State Citizens" have the right to maintain, control, protect and develop their cultural heritage, traditional knowledge and traditional cultural expressions, as well as, the manifestations of their sciences, technologies and cultures, including human and genetic resources, seeds, medicines, knowledge of the properties of fauna and flora, oral traditions, literatures, designs, sports and traditional games and visual and performing arts. They also have the right to maintain, control, protect, and develop their intellectual property over such cultural heritage, traditional knowledge, and traditional cultural expressions.

2. In conjunction with indigenous peoples "NAMA nationals-American State Citizens", States shall take effective measures to recognize and protect the exercise of these rights.

- **Articles 32:** Rights to control land/resource use. Georgia *including* other union -states of America, uSA | USA, and all recognized domains, including Morocco, Mexico, GAR and the UPU must obtain free, prior, and informed consent through IROHEM before projects on sovereign territory.

Article 32 – Original

1. Indigenous peoples "NAMA nationals-American State Citizens", have the right to determine and develop priorities and strategies for the development or use of their lands or territories and other resources.

2. States shall consult and cooperate in good faith with the indigenous peoples "NAMA nationals-American State Citizens" concerned through their own representative institutions in order to obtain their free and informed consent prior to the approval of any project affecting their lands or territories and other resources, particularly in connection with the development, utilization, or exploitation of mineral, water or other resources.

3. States shall provide effective mechanisms for just and fair redress for any such activities, and appropriate measures shall be taken to mitigate adverse environmental, economic, social, cultural, or spiritual impact.

- **Articles 34 & 36:** Right to maintain legal systems and cross-border relations.

Article 34 – Original

Indigenous peoples "NAMA nationals-American State Citizens", have the right to promote, develop and maintain their institutional structures and their distinctive customs, spirituality, traditions, procedures, practices and, in the cases where they exist, juridical systems or customs, in accordance with international human rights standards.

Article 36 – Original

1. Indigenous peoples "NAMA nationals-American State Citizens", in particular those divided by international borders, have the right to maintain and develop contacts, relations, and cooperation, including activities for spiritual, cultural, political, economic, and social purposes, with their own members as well as other peoples across borders.
 2. States, in consultation and cooperation with indigenous peoples, "NAMA nationals-American State Citizens", shall take effective measures to facilitate the exercise and ensure the implementation of this right.
- **Articles 37:** Treaties, and Emperial & Imperial agreements are binding. Georgia *including* other union -states of America, uSA | USA, and all recognized domains, including Morocco, Mexico, GAR and the UPU shall honor all prior and current E & I concurrence.

Article 37 – Original

1. Indigenous peoples "NAMA nationals-American State Citizens", have the right to the recognition, observance and enforcement of treaties, agreements and other constructive arrangements concluded with States or their successors, and to have States honour and respect such treaties, agreements and other constructive arrangements.
 2. Nothing in this Declaration may be interpreted as diminishing or eliminating the rights of indigenous peoples "NAMA nationals-American State Citizens", contained in treaties, agreements, and other constructive arrangements.
- **Articles 38:** Georgia *including* other union -states of America, uSA/USA, and all recognized domains, including Morocco, Mexico, GAR and the UPU must take legislative and administrative measures to uphold these Rights.

Article 38 – Original

- States in consultation and cooperation with indigenous peoples "NAMA nationals-American State Citizens", shall take the appropriate measures, including legislative measures, to achieve the ends of this Declaration.
- **Articles 39:** Rights to access financial and technical assistance through state and international cooperation.

Article 39 – Original

Indigenous peoples "NAMA nationals-American State Citizens", have the right to have access to financial and technical assistance from States and through international cooperation, for the enjoyment of the rights contained in this Declaration.

No provision of this **EMOU** shall be interpreted or enforced in any manner inconsistent with UNDRIP or existing **Emperial, Imperial, Indigenous, or Treaty rights**. Any conflict shall be resolved in favor of such rights. These Rights are enforceable via IROHEM, ERP, IMYRS, and applicable diplomatic law.

VII. IMMUNITY & INVIOABILITY

All Emperial & Imperial missions, representatives, documents, seals, consular premises, and communications enjoy full diplomatic immunity and inviolability, as protected by the Vienna Convention, Treaty Law, UNDRIP, and E & I Law.

VIII. DISPUTE RESOLUTION

Disputes arising from this **EMOU** shall first be addressed by **Emperial** diplomatic channels. If unresolved, recourse shall be to mutually agreed peaceful means, including Emperial tribunals or international arbitration, always giving effect to UNDRIP and **Emperial & Imperial** rights.

IX. NOTICES & AUTHENTICATION

Official notices shall be delivered by ERP registered post, IMYRS entry, and/or signed consular notice, and may be authenticated via IMYRS digital registry and Imperial & Imperial cryptographic signature.

X. TERMS, TERMINATION & ENFORCEABLY

- **Effectivity:** The EMOU takes effect immediate upon execution by H.E.M., IMYRS record and diplomatic delivery.
- **Term:** Ten E & I Years (IMYRS calendar), renewable unless 120 days' notice is given.
- **Amendments:** By written, signed mutual agreement.
- **Termination:** May only be executed by the IROHEM, and/or by lawful written notice with peaceful protocol in accordance with the IROHEM.

Breach of terms shall trigger notification to international oversight bodies, including the United Nations and treaty depositaries, for lawful remedy *pursuant to the Royal Imperial-Motu Proprio to the World—9 August 2025, ARTICLE. II – Notice to Heads of State (2.2).*

XI. SEVERABILITY & SUPREMACY

If any part is found invalid, the remainder remains in force. Within Imperial estate and consular affairs, Imperial Law prevails.

XII. APPENDIX: ESTATE PROPERTIES, CONSULAR SITES & NOTIFICATION ADDRESSES



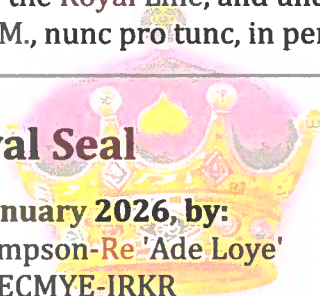

- The presence, property, and ceremonial acts of H.E.M.—including any residence, estate, consular post, archive, or ceremonial site named in Imperial & Imperial decrees or IMYRS—constitute lawful, sovereign Imperial jurisdiction.

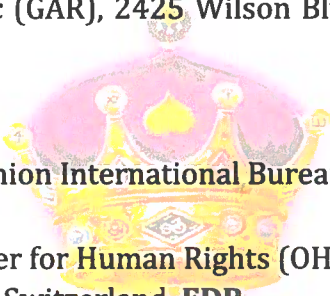
