I. DECLARATION OF MONETARY & COSMIC AUTHORITY

Pursuant to:

- Emperor's Directive-0004Z — ICCMYE (3 April 2013)
- Imperial CMYE Government Decree ED-0013Z (21 February 2019)
- Imperial Position Paper on Monetary Sovereignty (20 February 2026)

All monetary, fiscal, institutional, diplomatic, territorial, and sovereign authority:

Originates in the Sovereign CROWN/Crown.

Exists before the structure.

Operates independently of commercial systems.

Is autochthon, treaty-secured, and constitutionally vested.

This Cosmic Mandate does not create sovereignty.

It affirms and operationalizes the Sovereign Monetary Authority.

II. SOVEREIGN FINANCIAL ORDER OF DOMINION

The Crown establishes a structured dominion:

Fiscal Dominion → Imperial CMYE Treasury (ICMYET)

Monetary Dominion → NAMA International Central Banque (NICB)

Institutional Banking Dominion → NAMA Global Banque (NGB)

All authority:

Flows downward from the CROWN/Crown.

Remains revocable.

It is derivative and subordinate.

It is sealed under Royal Gold-Credit Supremacy.

III. COSMIC PURPOSE OF THE ICMYET

The Imperial CMYE Treasury (ICMYET):

- Supreme Sovereign Fiscal Organ
- Custodian of Sovereign Gold-Credit
- Administrator of Allodium Estate Fiscal Authority
- Issuer of Sovereign Treasury Instruments
- Guardian of Imperial Public Wealth
- Fiscal Stabilization Arm of the Imperial & Imperial Financial Enterprise System (E&IFES)

As affirmed in the Treasury-Executive Mission (5 February 2024).

IV. SOVEREIGN GOLD-CREDIT DOCTRINE

As codified in the Position Paper on Monetary Sovereignty:

All fiscal instruments are:

Estate-backed
Gold-anchored
Treaty-protected
Sovereign in character

Treasury reserves are secured through:

- Precious metals
- Allodium Estate holdings
- Treaty-recognized sovereign rights
- NAMA Sovereign Gold Instruments (including 999 Sextillion Bond)

No private commercial code supersedes the CROWN/Crown Monetary Authority.

V. FISCAL POWERS VESTED

ICMYET is vested with plenary authority to:

- Allocate sovereign budgets
- Issue treasury certificates
- Authorize NAMA Gold Bond deployments
- Maintain stabilization reserves
- Establish sovereign trust & escrow structures
- Open humanitarian corridors
- Implement emergency monetary stabilization

All actions require IMYRS registration and Royal Seal authentication.

VI. COSMIC JURISDICTIONAL SCOPE

Authority extends:

- Upon the land (Allodium Estate)
- Across treaty-recognized jurisdictions
- Within diplomatic financial corridors
- Through UPU/Bern protections (1874)
- Under Vienna Convention protections (1961/1969)
- Under Treaty of Peace & Friendship (1786-87/1836-37)

In full conformity with the Position Paper, legal expansion.

VII. STRUCTURAL GOVERNANCE

A. Supreme Fiscal Sovereign

H.E.M. retains ultimate Treasury authority.

B. Treasury High Council (IROHEM Appointed)

- Grand Chancellor of the Treasury
- Sovereign Gold-Credit Custodian
- Estate & Land Asset Comptroller
- Treaty Compliance Marshal
- Audit & Integrity Guardian

All offices operate under Royal Seal Authority.

VIII. IMMUNITY & PROTECTION

Pursuant to ICCMYE and ED-0013Z:

- Treasury assets are inviolable.
- Sovereign Immunity applies.
- Interference constitutes a violation of Emperial Economic Jurisdiction.
- Treaty protections apply nunc pro tunc.

IX. PERPETUAL ASSERTION & RETROACTIVITY

This Comic Mandate is effective nunc pro tunc to:

- 9 August 2025 (Royal Emperial-Motu Proprio)
- 3 April 2013 (ICCMYE Activation)
- 18 July 2007 (CMYE Foundational Emergence)

Binding in perpetuity ad infinitum.
