PURPOSE

Ameni-Abwoon: This Administrative Assessment has been prepared to document the Imperial Royal Office for His-Emperial-Majesty's assessment of alleged institutional damages arising from matters documented during the Imperial Guardians Administrative Investigation (IGAI).

The purpose of this assessment is to:

- preserve the governmental record;
- document the investigative chronology;
- summarize the categories of alleged institutional harm identified during the administrative investigation;
- record the methodology used for internal administrative calculations;
- preserve the chain of custody of documentary and electronic evidence; and
- provide an organized administrative reference for any future governmental review authorized by His-Emperial-Majesty.

This Administrative Assessment is administrative in nature. It documents an internal governmental assessment based upon the evidence preserved by the Imperial Guardians Administrative Investigation and is intended to support the continuing administration of the investigation and the preservation of the governmental record. It is not, by itself, a judicial judgment, criminal conviction, or adjudicated debt.
